### APPROPRIATION (SUPPLEMENTARY SUPPLY) ACT, 1995

(Assented to , 1995)

MOST GRACIOUS SOVEREIGN:

**Preamble** WHEREAS it appears by a Message from His Honour, Gordon Towers, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the Message, that the sums hereinafter mentioned are required to defray certain expenditures of the Public Service of Alberta not otherwise provided for during the fiscal year ending March 31, 1995, and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

1994-95** **1** From and out of the General Revenue Fund, there may be paid and applied a sum not exceeding, in the whole, \$10 403 000 towards defraying the further charges and expenses of the Public Service from April 1, 1994 to March 31, 1995, not otherwise provided for, being the total of the supplementary votes set forth in the Schedule to this Act.

**Accountability** **2** The due application of all money expended under this Act shall be accounted for.

## **SCHEDULE**

### **ADVANCED EDUCATION AND CAREER DEVELOPMENT**

**Operating Expenditure** \$ 10 400 000

To authorize the transfer of \$14 000 000 for the purposes of this vote from the operating expenditure vote under the Department of Family and Social Services in the Appropriation Act, 1994 and to provide a further amount of \$10 400 000.

### **COMMUNITY DEVELOPMENT**

**Operating Expenditure** 1 000

To authorize the transfer of \$9 740 000 for the purposes of this vote from the operating expenditure vote under the Department of Family and Social Services in the Appropriation Act, 1994.

### **FAMILY AND SOCIAL SERVICES**

**Capital Investment** 1 000

To authorize the transfer of \$450 000 for the purposes of this vote from the operating expenditure vote under the Department of Family and Social Services in the Appropriation Act, 1994.

## HEALTH

### Operating Expenditure

To authorize the transfer of \$7 500 000 for the purposes of this vote from the operating expenditure vote under the Department of Community Development and \$40 000 000 for the purposes of this vote from the capital investment vote under the Department of Public Works, Supply and Services in the Appropriation Act, 1994.
