CITY OF EDMONTON AUTHORITIES REPEAL ACT

(Assented to , 1995)

WHEREAS The Edmonton Convention Centre Authority was incorporated by *The Edmonton Convention Centre Authority Act*, being chapter 75 of the Statutes of Alberta, 1979, as amended by chapter 58 of the Statutes of Alberta, 1983, chapter 74 of the Statutes of Alberta, 1984 and chapter 56 of the Statutes of Alberta 1985; and

WHEREAS The Edmonton Research and Development Park Authority was incorporated by *The Edmonton Research and Development Park Authority Act*, being chapter 93 of the Statutes of Alberta, 1980, as amended by chapter 75 of the Statutes of Alberta, 1984, chapter 56 of the Statutes of Alberta, 1985 and chapter 43 of the Statutes of Alberta, 1990; and

WHEREAS the Edmonton Convention and Tourism Authority was incorporated by the *Edmonton Convention and Tourism Authority Act*, being chapter 37 of the Statutes of Alberta, 1982, as amended by chapter 59 of the Statutes of Alberta, 1983 and chapter 56 of the Statutes of Alberta, 1985; and

WHEREAS the Edmonton Economic Development Authority was incorporated by the *Edmonton Economic Development Authority Act*, being chapter 38 of the Statutes of Alberta, 1982, as amended by chapter 56 of the Statutes of Alberta, 1985 and chapter 49 of the Statutes of Alberta, 1987; and

WHEREAS the assets and liabilities of each of The Edmonton Convention Centre Authority, The Edmonton Research and Development Park Authority, the Edmonton Convention and Tourism Authority and the Edmonton Economic Development Authority were transferred to and acquired by Economic Development Edmonton, a company incorporated pursuant to Part 9 of the *Companies Act* (Alberta), effective as of December 31, 1992; and

WHEREAS a petition has been presented for the repeal of *The Edmonton Convention Centre Authority Act*, *The Edmonton Research and Development Park Authority Act*, the *Edmonton Convention and Tourism Authority Act* and the *Edmonton Economic Development Authority Act* and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

- 1 *The Edmonton Convention Centre Authority Act* is repealed.
- 2 *The Edmonton Research and Development Park Authority Act* is repealed.
- 3 The *Edmonton Convention and Tourism Authority Act* is repealed.
- 4 The *Edmonton Economic Development Authority Act* is repealed.
