INSURANCE STATUTES AMENDMENT ACT, 1999

(Assented to , 1999)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Insurance Act (RSA 1980 cl-5)

Amends RSA 1980 cl-5

RSA 1(1) The Insurance Act (RSA 1980 cl-5) is amended by this section.

(2) Section 1 is amended

(a) by adding the following after clause (e.101):

- (e.102) "common law relationship" means a relationship between 2 people of the opposite sex who although not legally married to each other
 - (i) have continuously cohabited in a marriage-like relationship for at least 3 years, or
 - (ii) if there is a child of the relationship by birth or adoption, have cohabited in a marriage-like relationship of some permanence;

(b) by adding the following after clause (v):

- (v.01) "spouse" means
 - (i) a spouse of a married person, and
 - (ii) a party to a common law relationship;

(2) Section 1 is amended

- (i.1) "common law relationship" means a relationship between 2 people of the opposite sex who although not legally married to each other
 - (i) have continuously cohabited in a marriage-like relationship for at least 3 years, or
 - (ii) if there is a child of the relationship by birth or adoption, have cohabited in a marriage-like relationship of some permanence;

(4) Section 562(3) is amended by striking out "16 years consents" and substituting "16 years, consent".

(2) Adds definitions.

- (3) Section 16(b) presently reads:
 - 16 The Lieutenant Governor in Council may make regulations
 - (b) prescribing classes of individuals for the purposes of section 7;
- (4) Section 562(3) presently reads:

(3) If the person whose life is insured is under the age of 16 years consents to insurance being placed on the person's life may be given by one of the person's parents or by someone standing in loco parentis to the person.

(5) Section 780(e) presently reads:

780 A person who contravenes any of the following provisions is guilty of an offence:
