WILLIAM ROPER HULL CHILD AND FAMILY SERVICES AMENDMENT ACT, 2000

Preamble WHEREAS the William Roper Hull Home was incorporated by the *William Roper Hull Home Act*, being chapter 117 of the Statutes of Alberta, 1954, which was amended by chapter 75 of the Statutes of Alberta, 1956, chapter 102 of the Statutes of Alberta, 1959, chapter 81 of the Statutes of Alberta, 1963, chapter 127 of the Statutes of Alberta, 1964, chapter 83 of the Statutes of Alberta, 1974 and chapter 66 of the Statutes of Alberta, 1987;

WHEREAS a petition has been presented praying that the Act be further amended as hereinafter set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Amends SA 1954 c117

1 The William Roper Hull Child and Family Services Act is amended by this Act.

2 The title of the Act is repealed and the following is substituted:

HULL CHILD AND FAMILY SERVICES ACT

3 Section 2 is amended by repealing clause (b) and substituting the following:

(b) "Corporation" means the body corporate created by this

Objects of Corporation **4** The objects of the Corporation are to promote the emotional and psychological well-being of children, adults and their families through the provision of educational, preventative and treatment services.

6 Section 6(1)(a) is repealed and the following is substituted:

(a) the Manager of the Trustee in the City of Calgary or such representative of the Trustee as the Manager of the Trustee may designate from time to time, and

7 Section 10(1) is amended by repealing clauses (f) and (g) and substituting the following:

- (f) control and regulate the admission of children, adults and their families into the programs of the Corporation, their maintenance while in the care of the Corporation and their discharge from the programs or care of the Corporation,
- (g) make rules, not inconsistent with any provisions of this Act, governing and prescribing the terms and conditions of admission of children, adults and their families to the programs of the Corporation, their maintenance and sojourn while in the care or custody of the Corporation and their discharge or departure from the programs of the Corporation,

- (b) "Corporation" means the body corporate created by this Act under the name of William Roper Hull Child and Family Services;

- **5** Section 4 presently reads:

4 The objects of the Corporation are to promote the emotional and psychological well-being of children and families through the provision of education, preventative and treatment services.

6 Section 6(1)(a) presently reads:

6(1) The Corporation shall, subject to the provisions of this Act, be managed and administered by a Board consisting of:

- (a) the Manager or acting Manager, for the time being, of the Trustee in the City of Calgary, and
- **7** Section 10(1) presently reads:

10(1) The powers of the Corporation are vested in and shall be exercised by the Board and, without restricting the generality of the foregoing, the Board may:

- (a) elect its own Chairman and Vice-Chairman and appoint a Treasurer and Secretary and such other officers of the Corporation as it deems expedient and may prescribe their respective duties, powers and authority and determine the tenure of each such office,
- (b) fix and determine the remuneration of the officers of the Corporation and of members of the Board other than those members referred to in clause (a) of section 6,
- (c) plan, organize, supervise, control, direct and carry out or cause to be carried out the construction, extension, equipment, operation and maintenance of the Corporation,
- (d) control, manage, govern and direct the Corporation and appoint such staff, employees, servants and agents as it may from time to time require or deem necessary and fix, pay and provide for the salaries, emoluments of, and benefits for, such persons,

- (e) act by such committees of, or appointed by, the Board as it deems proper to constitute or appoint,
- (f) control and regulate the admission of children and their families into the programs of the Corporation, and their maintenance while in the care of the Corporation, and their discharge from the programs or care of the Corporation,
- (g) make rules, not inconsistent with any provisions of this Act, governing and prescribing the terms and conditions of admission of children and families to the programs of the Corporation, their maintenance and sojourn while in the care or custody of the Corporation, and their discharge or departure from the programs of the Corporation,
- (h) make by-laws, resolutions, rules and regulations, not inconsistent with any of the provisions of this Act, touching or respecting any and all the aforesaid powers and matters and also in respect of all matters pertaining to the business, meetings and proceedings of the Board.
