MOST GRACIOUS SOVEREIGN:

Preamble

WHEREAS it appears by a Message from Her Honour Lois E. Hole, Lieutenant Governor of the Province of Alberta, and the Supplementary Estimates accompanying the Message, that the sums hereinafter mentioned are required to defray certain charges and expenses of the Legislative Assembly and the Public Service of Alberta, not otherwise provided for during the fiscal year ending March 31, 2002 and for other purposes relating thereto:

MAY IT THEREFORE PLEASE YOUR MAJESTY that it be enacted and be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Alberta, as follows:

1(1) From the General Revenue Fund, there may be paid and applied a sum of \$142 000 towards defraying the further charges and expenses of the Legislative Assembly classed as operating expense for the fiscal year ending March 31, 2002, not otherwise provided for, as shown in the Schedule.

(2) From the General Revenue Fund, there may be paid and applied a sum of \$354 971 000 towards defraying the further charges and expenses of the Public Service classed as operating expense and capital investment for the fiscal year ending March 31, 2002, not otherwise provided for, as shown in the Schedule.

- Non-Budgetary Disbursements **2** From the General Revenue Fund, there may be paid and applied a sum of \$80 000 000 towards defraying the further charges and expenses of the Public Service classed as Non-Budgetary Disbursements for the fiscal year ending March 31, 2002, not otherwise provided for, as shown in the Schedule.
- Transfer **3** The sum of \$2 797 000 in the Operating Expense vote of the Office of the Chief Electoral Officer is transferred to the Operating Expense vote of the Support to the Legislative Assembly.
- Accountability **4** The due application of all money expended under this Act shall be accounted for.
