HEALTH INSURANCE PREMIUMS ACT REPEAL ACT

(Assented to _____, 2001)

HER MAJESTY, by and with the advice and consent of the
Legislative Assembly of Alberta, enacts as follows:

Repeals RSA
1980 cH-5

1 The *Health Insurance Premiums Act* is repealed.

2 The *Alberta Health Care Insurance Act* is amended

(a) in section 4

(i) by adding the following after subsection (1):

(1.1) Subject to this Act and the regulations, every resident shall register with the Minister.

(ii) in subsection (5) by striking out “under the *Health Insurance Premiums Act*” and substituting “under this Act”;

(b) in section 6 by adding the following after clause (a.1):

(a.2) governing the registration of residents with the Minister generally;

(a.3) prescribing the classes of dependants that a resident is required to register;

(a.4) prescribing the classes of persons exempted

from registration;

- (a.5) providing for residents who elect to be outside the Plan and the Hospitalization Benefits Plan under Part 3 of the *Hospitals Act* to make declarations to that effect;

(c) in section 13(4.2)

- (i) **by striking out** “or the *Health Insurance Premiums Act*” **wherever it occurs**;

- (ii) **in clause (a) by striking out** “under those Acts” **and substituting** “under this Act”;

- (iii) **in clause (b) by striking out** “, the *Health Insurance Premiums Act* or the regulations under those Acts” **and substituting** “or the regulations under this Act”.

(d) in section 37

- (i) **in subsection (1)(a) by striking out the following:**

“on payment of the premiums prescribed therefor under the regulations made pursuant to the *Health Insurance Premiums Act*”;

- (ii) **by repealing subsection (2)**;

(e) in the following sections by striking out “or the *Health Insurance Premiums Act*” wherever it occurs:

section 6(m);
section 13(1), (5.5) and (5.6).
