COMMUNITY SCHOOL PARTNERSHIPS ACT

(Assented to , 2002)

Preamble

WHEREAS schools play a vital role in strengthening Alberta's communities;

WHEREAS the use of existing school facilities for community programs is an efficient use of public resources and an effective way to revitalize inner-city neighbourhoods and rural communities;

WHEREAS there is a need to coordinate and integrate school services with the supports and programs available in communities; and

WHEREAS the creation of partnerships between schools and communities will enhance educational opportunities for all members of the community and will contribute to the establishment of strong, vibrant communities;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Interpretation

- 1 In this Act,
 - (a) "board" means a board as defined in the School Act;
 - (b) "community school" means a school designated under section 4 that offers programs outside school hours to students and other members of the community;
 - (c) "community school coordinator" means the person appointed by a board pursuant to section 5;

- (d) "Minister" means the Minister determined under section 16 of the *Government Organization Act* as the Minister responsible for this Act;
- (e) "school building" means a school building as defined in the *School Act*.

Application

2 This Act applies to schools operated by a board.

Community schools

- **3** The mandate of a community school is to strengthen the community by
 - (a) developing partnerships with community groups and agencies,
 - (b) delivering programs or services outside regular school hours in the areas of
 - (i) child care,
 - (ii) computer training,
 - (iii) health education,
 - (iv) literacy,
 - (v) sports and recreation, or
 - (vi) any other area approved by the board,
 - (c) making existing school facilities available to all members of the community outside regular school hours.

Board

- 4 A board may designate a community school if it is satisfied that
 - (a) a community school would enhance the availability of the programs outlined in section 3(b),
 - (b) existing school buildings could be used for the community school, and
 - (c) the school would benefit the community.

Community

5(1) A board must appoint a community schools coordinator.

schools coordinator

- (2) A community schools coordinator is responsible for
 - (a) coordinating proposals for community schools,
 - (b) advising the board on proposals for community schools,
 - (c) providing ongoing advice to community schools, and
 - (d) serving as a liaison between community schools, community agencies and the board.

Proposals

- **6**(1) A school operated by a board may submit a proposal for a community school on or before January 31 each year.
- (2) A proposal under this section must include
 - (a) a mission statement for the community school,
 - (b) a description of the types of programs and community initiatives that would be made available, and
 - (c) a plan outlining the utilization of existing school buildings for the community school.
- (3) A board must make determinations on proposals for community schools on or before July 31 each year.

School closure

- **7** A board shall not exercise its authority to close a school pursuant to Alberta Regulation 238/97 if
 - (a) the school has been designated as a community school under this Act, or
 - (b) the school has submitted a community school proposal under section 6.

Regulations

8 The Minister may make regulations regarding types of activities and programs that may be offered at community schools.

Coming into force

9 This Act comes into force on January 1, 2004.
