HEALTH PROFESSIONS STATUTES AMENDMENT ACT, 2007 (NO. 2)

(Assented to , 2007)

HER MAJESTY, by and with the advice and consent of the
Legislative Assembly of Alberta, enacts as follows:

Health Professions Act

Amends RSA 2000 cH-7

1(1) The *Health Professions Act* is amended by this section.

**(2) Section 126(1) is amended by adding the following after
clause (d):**

- (d.1) a person who, at the request of the council of a college of a regulated profession, performs an assessment of the competence of an individual who has applied for registration to provide professional services of the regulated profession.

Explanatory Notes

Health Professions Act

1(1) Amends chapter H-7 of the Revised Statutes of Alberta 2000.

(2) Section 126(1) presently reads:

126(1) No action lies against any of the following in respect of anything done or omitted to be done in good faith pursuant to this Act, the bylaws or any direction of the council:

- (a) a college or a person who is or was an officer, employee or agent of a college;*
- (b) a person who conducts or has conducted an investigation or an alternative complaint resolution process under Part 4 or a practice visit;*
- (c) the council or a person who is or was a member of a council, committee or hearing tribunal of a college;*
- (d) a person who acts on the instructions of or under the supervision of a person referred to in clauses (a) to (c).*

Medical Profession Act

Amends RSA 2000 cM-11

2(1) The *Medical Profession Act* is amended by this section.

(2) Section 97(1) is amended by adding the following after clause (c):

- (c.1) a person who, at the request of the council, performs an assessment of the competence of an individual who has applied for registration to practise as a medical practitioner under this Act;

Medical Profession Act

2(1) Amends chapter M-11 of the Revised Statutes of Alberta 2000.

(2) Section 97(1) presently reads:

97(1) No action lies against any of the following in respect of anything done in good faith pursuant to this Act, the bylaws or any direction of the council:

- (a) the College or a person who is or was an officer, employee or agent of the College;*
- (b) a person who conducts an investigation under Part 4;*
- (c) the council or a person who is or was a member of the council or a member of a committee established by or under this Act;*
- (d) a person who acts on the instructions of, or under the supervision of, a person referred to in clauses (a) to (c).*
