HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

#### **Interpretation**

**1** In this Act, “Minister” means the Minister determined under section 16 of the *Government Organization Act* as the Minister responsible for this Act.

#### **Annual report of legislation not in force**

**2(1)** In 2016 and in every subsequent calendar year, the Minister shall lay before the Legislative Assembly, within the first 15 days on which the Legislative Assembly sits in that year, a report listing every Act or provision of an Act that is stated to come into force on Proclamation and that

- (a) was assented to 5 years or more before January 1 of the calendar year in which the report is laid before the Legislative Assembly, and
- (b) had not come into force by December 31 of the preceding calendar year.

(2) If an Act or a provision of an Act referred to in subsection (1) is, in the opinion of the Minister, substantially amended during the 5-year period immediately before January 1 of the calendar year in which the report is to be laid, that Act, or that provision of an Act and any other related provision in that same Act, must not be listed in a report until the calendar year following the 5th anniversary of the assent to the substantial amendment.

#### **Automatic repeal**

3 Every Act and provision that is listed in a report under section 2 and that is not in force on December 31 of the calendar year in which the report is laid before the Legislative Assembly is repealed on that December 31 unless, during that calendar year, that Act or provision is proclaimed into force or the Legislative Assembly adopts a resolution that the Act or provision not be repealed.

#### **Publication**

4 Each year, the Minister shall publish in *The Alberta Gazette* a list of the Acts and provisions, if any, repealed under section 3 on the preceding December 31.

#### **Obsolete Acts**

5 The Chief Legislative Counsel shall, from time to time, provide to the Minister a list of public Acts that have been rendered obsolete by events or the passage of time.

**13(1)** The *Health Facilities Review Committee Act*, RSA 2000 cH-3, is repealed.

**(2)** The *Public Inquiries Act* is amended by repealing section 7(2)(b)(ii) and substituting the following:

(ii) an approved hospital under the *Hospitals Act*,

- (ii.1) any other hospital, institution or other facility for the treatment and care of persons that is owned and operated by the Government of Alberta, except those operated under the administration of the Minister of Human Services or those that receive their current operating funds or part of them from a supply vote that is under the administration of a member of the Executive Council other than the Minister of Health,
- (ii.2) a hospital under the jurisdiction of a provincial health board under the *Regional Health Authorities Act*,
- (ii.3) a nursing home as defined in the *Nursing Homes Act*, and

**14(1) The *Hospitals Amendment Act*, RSA 2000 c14 (Supp), is repealed.**

**(2) If this section comes into force before the coming into force of section 4 of the *Health Facilities Accountability Statutes Amendment Act, 2007*, the *Health Facilities Accountability Statutes Amendment Act, 2007* is amended by repealing section 4.**

**15 The *Landlord's Rights on Bankruptcy Act* is amended by repealing section 2(b).**

**Repeals RSA 2000 cM-7**

**16(1) The *Masters and Servants Act*, RSA 2000 cM-7, is repealed.**

**(2) The *Proceedings Against the Crown Act* is amended by repealing section 10.**

**Repeals SA 2004 c25**

**17 The *Metis Settlements Amendment Act, 2004*, SA 2004 c25, is repealed.**

Repeals RSA 2000 c21 (Supp)

**18** The *Municipal Government Amendment Act*, RSA 2000 c21 (Supp), is repealed.

**22(1)** The *Pension Fund Act*, RSA 2000 cP-4, is repealed.

**(2)** The *Financial Administration Act* is amended in section 46(a) by striking out “, the *Pension Fund Act*”.

**(3)** The *Members of the Legislative Assembly Pension Plan Act* is amended by repealing section 12.

Repeals RSA 2000 cR-18

**23** The *Road Building Machinery Equipment Act*, RSA 2000 cR-18, is repealed.

Repeals SA 2006 c30

**24** The *Securities Amendment Act, 2006*, SA 2006 c30, is repealed.

Repeals RSA 2000 cS-10

**25(1)** The *Social Care Facilities Licensing Act*, RSA 2000 cS-10, is repealed.

**(2)** The *Protection for Persons in Care Act* is amended by repealing section 1(1)(m)(v) and substituting the following:

- (v) a hostel or other establishment operated to provide accommodation and maintenance for unemployed or indigent persons,

**(3) The *Public Health Act* is amended in section 1(x) by striking out “a social care facility as defined in the *Social Care Facilities Licensing Act*” and substituting “a hostel or other establishment operated to provide accommodation and maintenance for unemployed or indigent persons”.**

**(4) The *Residential Tenancies Act* is amended by repealing section 2(2)(h).**

**(5) The *Supportive Living Accommodation Licensing Act* is amended**

**(a) by repealing section 2(2)(c) and substituting the following:**

- (c) a hostel or other establishment operated to provide accommodation and maintenance for unemployed or indigent persons, or

**(b) by repealing sections 24(2)(j) and 25.**

**(6) The *Tobacco Reduction Act* is amended by repealing section 1(a.1)(iv) and substituting the following:**

- (iv) a residential facility operated to provide accommodation and maintenance for unemployed or indigent adults only, or

**(7) This section comes into force on Proclamation.**

**Repeals SA 2005 c19**

**26 The *Stray Animals Amendment Act, 2005*, SA 2005 c19, is repealed.**

**Repeals RSA 2000 cW-6**

**27(1) The *Wheat Board Money Trust Act*, RSA 2000 cW-6, is repealed.**

**(2) The trust established by the Act is revoked.**



(3) The Board of Trustees established by the Act is dissolved and all appointments to the Board are terminated.

(4) All money being administered by the Board immediately before this section comes into force is deemed to form part of the Fund referred to in section 2(1) of the *Alberta Heritage Scholarship Act*.

(5) This section comes into force on January 1, 2014, and is repealed on Proclamation.
