## CANADIAN UNIVERSITY COLLEGE AMENDMENT ACT, 2015

#### Preamble

WHEREAS the Canadian Junior College was incorporated by chapter 35 of the Statutes of Alberta, 1940;

WHEREAS that Act was amended by chapter 82, Statutes of Alberta, 1947, which, *inter alia*, changed the name of the College to "Canadian Union College";

WHEREAS the Act was further amended by chapter 104, Statutes of Alberta, 1951; chapter 124, Statutes of Alberta, 1972; chapter 74, Statutes of Alberta, 1979; chapter 24, Statutes of Alberta, 1989; chapter 30, Statutes of Alberta, 1993; and chapter 30, Statutes of Alberta, 1997, which changed the name of the college to "Canadian University College"; and

WHEREAS the petitioner is praying that the Act be amended to change the name of the College to "Burman University" and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

#### Amends SA 1940 c35

- 1 The Canadian University College Act is amended by this Act.
- 2 The title of the Act is struck out and the following is substituted:

- **1** Amends chapter 35 of the Statutes of Alberta, 1940.
- 2 Name change.

#### **BURMAN UNIVERSITY ACT**

#### 3 The preamble is repealed and the following is substituted:

WHEREAS the Canadian Junior College was incorporated by chapter 35 of the Statutes of Alberta, 1940;

WHEREAS the College changed its name to "Canadian Union College" pursuant to chapter 82, Statutes of Alberta, 1947, and the College subsequently changed its name to "Canadian University College" pursuant to chapter 30, Statutes of Alberta, 1997; and

WHEREAS the petition is seeking amendments to the Act to provide for a further change in name of the College to "Burman University" and it is expedient to grant the prayer of the petition;

#### 4 Section 1(1) is repealed and the following is substituted:

#### Continuation

**1(1)** The Canadian University College is continued as a corporation under the name "Burman University" and shall consist of those members of the Seventh-day Adventist Church who are elected or appointed pursuant to the by-laws.

# 5 The following provisions are amended by striking out "Canadian University College" wherever it occurs and substituting "Burman University":
