PAULA JEAN ANDERSON ADOPTION TERMINATION ACT

Preamble

WHEREAS by order of the Honourable Judge H.S. Rowbotham in the District of Southern Alberta, Judicial District of Calgary, it was ordered that the Petitioner, Paula Jean Madsen, as she was then known, be declared to be, from and after April 16, 1974, the adopted child of Donald Harold Ainsworth and be given the name of Paula Jean Ainsworth;

WHEREAS the adoption order can no longer be appealed against by reason of a lapse of time;

WHEREAS the Petitioner married Kevin Andrew Kelly on June 19, 1993, and at that time assumed the name Paula Jean Kelly;

WHEREAS by order of the Honourable Justice J.K. Holmes in the Judicial District of Red Deer, it was ordered that the Petitioner, Paula Jean Kelly, as she was then known, be divorced from Kevin Andrew Kelly, effective May 31, 1998;

WHEREAS the Petitioner married James Stanley Anderson on August 22, 1998, and at that time assumed the name of Paula Jean Anderson; and

WHEREAS the Petitioner has presented a petition that it be enacted as herein set forth and it is expedient to grant the prayer of the petition;

THEREFORE HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

Cancellation of adoption

1 The order dated and entered on April 16, 1974, whereby Paula Jean Madsen was declared to be the adopted child of Donald Harold Ainsworth and to be named Paula Jean Ainsworth is hereby terminated.

Termination of kinship and inheritance rights

2 Paula Jean Anderson is hereby declared not to be the lawful child and heir of Donald Harold Ainsworth and not to have any rights of inheritance from Donald Harold Ainsworth that would otherwise devolve on her by law.
