## No. 32 of 1916.

An Act to Amend the Act Incorporating the Village of Lake View, being Chapter 39 of the Statutes of Alberta, 1913 (Second Session).

> (Assented to , 1916.)

WHEREAS the Village of Wabamun has petitioned that the Act providing for the severance therefrom of blocks numbered 12, 13, 14, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 29a, and block P, registered as plan 3682 A.J. and establishing the same as a separate village under the name of "The Village of Lake View", being chapter 39 of the Statutes of Alberta, 1913 (Second Session), may be amended as hereinafter set forth;

And whereas it is expedient to grant the prayer of the said petition;

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The said Act being chapter 39 of the Statutes of Alberta, 1913 (Second Session), is amended as follows: Section 2; by adding after "16" in line 1 thereof the numbers "17," "18" and "19."

2. By adding to the said Act the following new sections: "17. The council of the Village of Wabamun shall have the power to assess and levy a debenture rate against the said lands and the owners thereof or those beneficially interested therein for all debentures issued by the said Village of Wabamun or authorized under section 77 of The Village Act prior to the 31st day of December, 1913, and the provisions of The Village Act, and all amendments thereto or hereafter made or any Act passed in substitution therefor, relating to assessment, taxation, collection of taxes, and forfeiture of land for nonpayment of taxes, shall mutatis mutandis apply in all respects as if said lands had not been withdrawn from the Village of Wabamun.

"18. The amount levied on the said lands, and the owners thereof or those beneficially interested therein by the council of the Village of Wabamun for the year 1916 shall include the amount of taxes that would have been payable in respect to the said lands for the said debentures in the years 1914 and 1915, together with the penalties for nonpayment if said lands had not been withdrawn from the Village of Wabamun, and if the assessment for the years 1914 and 1915 had been the same as for the year 1913.

"19. All taxes accruing due under sections 17 and 18 hereof shall be a first charge on said lands, and shall have priority over every claim, lien, privilege or encumbrance thereon, except claims of the Crown.

"20. The council of the Village of Wabamun may, if they deem it advisable, accept a lump sum from the Village of Lake View in each or any year in payment of the amount of taxes for which the said lands are or would be liable under sections 17 and 18 hereof, and in such case the Village of Lake View shall have the power to raise the amount of such payment by taxation levied on the said lands or the owners thereof.

owners thereof. "21. All costs incurred by the Village of Wabamun in connection with this amending Act shall be payable by the Village of Lake View." Bill No. 32.
