An Act to amend The Town Act.

, 1916.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

The Town Act, being chapter 2 of the Statutes of Alberta, 1911-12, is amended as follows:

1. Section 2, subsection 1: By adding the following: "21. 'Special franchise' means every right, authority or permission to construct, maintain or operate, within a municipality, in, under, upon, on or through, any highway, road, street, lane, public place or public water, within the jurisdiction of the municipality any poles, wired, tracts, pipes to conduits, buildings, aqueducts, viaducts, erecting structures or other buildings for the purpose of bridges, railways, tramways, or for the purpose of conducting steam, heat, compressed air, water, gas, oil, electricity, electrical current or any property, substance or product, capable of being transported, transmitted or conveyed, for the supply of natural light, heat, power, transportation, telegraphic, telephonic or other service."

2. Section 2, clause 14: By striking out the word "village" wherever it occurs in the said subclause.

3. Section 19: By striking out the words "provided by law" in the last line of the said section and substituting therefor the words "hereinafter mentioned", and by adding thereto the following:

"(2) Where any person as chairman or member of the council has filed an affidavit showing that a member of the council has forfeited his seat at the council or his right thereto or has become disqualified to hold his seat or his seat has become vacant by disqualification or otherwise, and has paid into court the sum of \$25.00 as security for costs to abide the event of the application, it shall be lawful for the judge of the District Court of the judicial district within which the district is wholly or partly situated, or if the district is equally situated within more than two judicial districts, for the judge of the District Court of any such judicial district to grant a summons calling upon such person to show cause why he should not be ousted from the office; and where upon the return of the summons it shall appear to the judge upon affidavit or oral evidence that such member of the council has forfeited his seat at the council or his right thereto, or has become disqualified to hold his seat or his seat has become vacant by dis-qualification or otherwise, the judge may adjudge such person to be ousted of the same and such person shall be ousted of the same accordingly, or the judge may discharge the summons and in either case with or without costs."

4. Section 163: By repealing clause 3.

By repealing clause 4 and substituting therefor the following:

"Subject to the approval of the Minister compromising upon such terms as may be agreed upon for payment of arrears of taxes on lands which have been subdivided under a plan registered at the land titles office."

By adding immediately after clause 60 the following as

clause 60a: "60a. Licensing automatic vending machines used for the sale of gum, matches or other articles."

5. Section 265: By inserting after the word "land" wherever it occurs in the said section the words "and special franchise.

6. By adding immediately after section 265, the following:

"265a. Any number of electors not less than 10% in number of the votes polled at the annual municipal election last held prior to the date of the petition herein referred to, may by petition in writing signed by such electors submit to the council a by-law to adopt a system of taxation for a period not exceeding four years from the 31st day of December, 1916, providing for the imposition of taxes on buildings and improvements as well as upon lands and special franchises. If such petition be filed in the office of the secretary not later than the first day of September in any year and contain a request that the said by-law if not passed by the council shall be submitted to a vote of the electors of the municipality, the council shall-

(a) Pass said by-law within sixty days without alter-

ation or amendment; or "(b) Submit such by-law to the vote of the electors at the next annual municipal election next to be held in the municipality.

"(2) If a majority of the electors voting on the proposed by-law shall vote in favour thereof, such by-law shall thereupon become a valid and binding by-law of the municipality, and as long as the same remains in force no taxes of any kind shall be levied in the municipality by the council except in accordance with such by-law.

"(3) Any such by-law which shall be adopted by a vote of the electors shall not be repealed or amended except by a majority vote of the electors to be taken pursuant to a subsequent petition presented to the council under this section

"265b. Petitions under the provisions of this Act may consist of one or more distinct papers. In each of such papers the full text of the by-law, the passage of which is requested, shall be set forth and all such papers filed in any one day in the office of the secretary shall be deemed to be part of the same petition. "265c. Each petitioner opposite his name shall state his

place of residence and his occupation. All signatures on the petition shall be witnessed and signed by the witness who shall verify the genuineness of such signatures by affidavit.

'265d. The poll or vote on any such by-law shall be taken in the same manner as is prescribed in this Act in the case of a by-law requiring the consent of the electors.

7. Section 267: By adding thereto the following: "(5) For the purpose of assessment and taxation it is hereby declared that the value of a special franchise is and shall be the amount of the difference between the actual value of all the property and assets of any person, firm or corporation, carrying on any business and owning and operating any public service utility in connection therewith, using, enjoying or possessing any special franchise including the value accruing from the use, possession or enjoyment of such special franchise and the value of the physical assets of such person, firm or corporation, used or held in connection with such business or public service utility, including land, rolling stock, railway and street railway tracts, and all machinery, fixtures, building structures, poles, wires, pipes to conduits, and other things, erected or placed upon, in, over, under or affixed to land, or any

highway, road, street, lane, public place or public water. "(6) Where by-law has been passed providing for the levying of taxes on buildings and improvements, such buildings and improvements shall be assessed at 60% of their actual value."

8. Section 328: By repealing same and substituting therefor the following:

328. Such return shall be brought up for confirmation before the District Court of the district in which the town is wholly or partly situated or a judge thereof at a sittings of the said court, and a notice of the time and place of such sittings shall be published in every issue of *The Alberta* Gazette for two months and once each week for at least eight weeks in a newspaper published in the municipality or if there be no newspaper published in the municipality in the newspaper circulating therein.

"(2) The date fixed for the confirmation of the return shall be the date of the sittings of the court at which the return is brought up for confirmation.'

9. Section 329: By striking out the form of notice set forth therein and substituting therefor the following:

"Such notice shall be in the following form:

10. Section 331, subsection 6: By striking out the words "sixty days and not more than ninety days" where the same appear in lines nine and ten in the said subsection and substituting therefor the words "thirty days and not more than sixty days."

11. Section 335: By adding thereto the following subsection: "(3) Where any land is sold under the provisions of this

"(3) Where any land is sold under the provisions of this section the town shall pay out of the proceeds of such sale any amount that may be due a rural municipality for municipal taxes; a local improvement district for local improvement taxes, or a consolidated school district for school taxes, and if the amount received for the land is not sufficient to pay in full all taxes, costs and penalties, the town shall after deducting all expenses incurred in connection with the tax enforcement proceedings apply the balance of the payment on the different taxes outstanding rateably to the amount of the taxes due the town, rural municipality, local improvement district or consolidated school district."
