## No. 47 of 1916.

### An Act respecting certain School Lands in the Taber Irrigation District.

#### , 1916.) (Assented to

WHEREAS the Government of the Province of Alberta has applied to the Government of Canada to pass, and to consent to the passing by the Legislature of the Province of Alberta, of such legislation as will permit of school lands within the meaning of *The Dominion Lands* Act, which are within the boundaries of the Taber Irrigation District, being dealt with under the provisions of The Irrigation District Act, 1915, as patented lands may be dealt with thereunder;

And whereas the Government of Canada has intimated its willingness to pass such legislation, but not until after an Act providing that the said lands may be so dealt with has been passed by the Legislature of the Province of Alberta;

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. Notwithstanding anything contained in any Act to the contrary, the school lands which are enumerated in the schedule to this Act, or any of them, and which are within the boundaries of the Taber Irrigation District, may be dealt with under the provisions of *The Irrigation* District Act in the same way as patented lands may be dealt with thereunder.
