### **PRAIRIE BIBLE INSTITUTE AMENDMENT ACT, 2026**

*(Assented to \_\_\_\_\_, 2026)*

#### **Preamble**

WHEREAS The Prairie Bible Institute was established by *An Act to Incorporate The Prairie Bible Institute*, being chapter 78 of the Statutes of Alberta 1946, which was amended by *An Act to Amend an Act to Incorporate The Prairie Bible Institute*, being chapter 120 of the Statutes of Alberta 1971, and *The Prairie Bible Institute Amendment Act, 1980*, being chapter 96 of the Statutes of Alberta 1980;

WHEREAS Prairie Bible Institute has presented a petition praying that *An Act to Incorporate Prairie Bible Institute* be amended, and it is expedient to grant the prayer of the petition;

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of Alberta, enacts as follows:

#### **Amends SA 1946 c78**

**1** *An Act to Incorporate Prairie Bible Institute* is amended by this Act.

**2** Section 2a is renumbered as section 2.1.

**3 Section 7a is repealed and the following is substituted:**

**7.1** Prairie Bible Institute has the authority to

- (a) grant degrees in divinity,
- (b) provide programs of study, approved in accordance with the *Post-secondary Learning Act* and the regulations made under that Act, that lead to the granting of baccalaureate, master's, and doctoral degrees, and
- (c) provide institutionally approved programs of study that lead to the granting of diplomas and certificates.

## Explanatory Notes

**1** Amends chapter 78 of the Statutes of Alberta 1946.

**2** Section 2a presently reads:

*Gift Annuity  
Agreements*

*2a. (1) The corporation may acquire gifts of money or property by agreement with the donor.*

*(2) The agreement may provide that the corporation shall pay to the donor or other person the income therefrom or an agreed rate of return thereon or on the agreed value thereof or any portion thereof.*

*(3) Unless the agreement otherwise provides, the corporation shall segregate from its other assets the money or property or proceeds thereof.*

*(4) Unless the agreement otherwise provides, the corporation may invest the money or property as it sees fit and it is not restricted to investments which may be made by trustees.*

*(5) At the death of the donor or other person to whom payments are to be made under the agreement, the corporation is entitled to use the money or property or proceeds thereof for carrying out the objects of the corporation.*

*(6) The corporation shall not pay or agree to pay any commission for securing such gifts.*

**3** Section 7a presently reads:

*Degrees in  
divinity*

*7a Prairie Bible Institute shall have the power to grant  
degrees in divinity.*
