#### No. 10 of 1919.

#### An Act respecting an Act to incorporate the Calgary Hospitals Board.

#### (Assented to , 1919.)

WHEREAS the City of Calgary has prayed for an Act vesting in the said city the hospital property transferred to the Calgary Hospitals Board under chapter 46, Statutes of Alberta, 1914;

And whereas it is deemed expedient to grant the prayer of the said petition:

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The property both real and personal, described in schedules A and B of said chapter 46 of the Statutes of Alberta, 1914, intituled "An Act Incorporating the Calgary Hospitals Board," together with all lands, tenements, and hereditaments corporeal and incorporeal, of every nature and description and every estate or interest therein, whether legal or equitable and all personal property of or belonging to the said Calgary Hospitals Board, or to which the said Calgary Hospitals Board is entitled to possession under the terms of said chapter 46, Statutes of Alberta, 1914, and hereby vested in the City of Calgary in trust for the ratepayers of the City of Calgary for hospital purposes.

2. The City of Calgary is hereby authorized and empowered to demand and to receive from the said Calgary Hospitals Board all the property hereinbefore described, to be held in trust by the said city for hospital purposes as aforesaid, and the said board by its proper officers in that behalf shall, upon demand from the city, execute all such transfers, deeds, conveyances, assignments and assurances as the city may deem necessary to effectually vest in the city the said property for the said purposes and to enable the city to enter into or recover possession by action at law or otherwise, of any of the said property that may now be in the possession of the said board, and the city shall, for the purposes of enabling the city to recover possession of any such property, be deemed the successor of the said Calgary Hospitals Board.

3. All the debts of the said board and of the Calgary General Hospitals Association due or accruing due on the date of the passing of this Act, shall be assumed and borne by the City of Calgary, and the said city shall indemnify the said board and the said association against any liability with respect thereto.

4. All the rights, powers and privileges of the said board are hereby transferred to and may be exercised by the council or commissioners of the City of Calgary, conjointly with or as supplementary to, and without in any way limiting or restricting, any rights, powers and privileges now or hereafter existing, under any Act or Ordinance enabling the said city to own, operate and maintain public hospitals, and all the said rights, powers and privileges shall be applicable to the said property, hereby vested in the city as aforesaid, in the same manner and to the same extent as to any other property acquired by the city for hospital purposes; provided that the said board by its proper officers may continue to exercise all the powers necessary to fulfil the purposes of the preceding section 2 hereof.

5. The agreement, appended to the said chapter 46, Statutes of Alberta, 1914, shall be deemed superseded by this Act and the said Act deemed amended so as to give full force and effect to this Act. No. 10.
