

# BILL

No. 60 of 1923.

An Act respecting Hospital Facilities in Connection with  
The University of Alberta.

(Assented to: 1923.)

**W**HEREAS by an instrument dated the thirty-first day of January, one thousand nine hundred and twelve, the Governors of the University of Alberta (hereinafter called "the Governors") lawfully leased to the City of Strathcona lands for the erection of a hospital, and provision was made in such instrument for the management of the hospital when erected on the said lands;

And whereas by chapter 60 of the Statutes of Alberta, 1922, it was enacted that the hospital then erected on the lands of the Governors should be deemed to be the hospital provided for by the said instrument and further provision was made therein for the constitution of the board of management of the said hospital as a body corporate, for the appointment of the members of the said board by the Lieutenant Governor in Council, the City and the Governors and for payment by the City of Edmonton in respect of hospital service to its residents;

And whereas it has been agreed between the City of Edmonton, successors in title of the said City of Strathcona (and hereinafter called "The City") and the Governors that the City should sell to the Governors its interest in the said hospital for the sum of one hundred and fifty thousand dollars, payable in the manner provided for in the agreement;

Now therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The University of Alberta Hospital Act.*"

**2.** The agreement between the Governors and the City for the sale by the City to the Governors of its interest in the said hospital for the sum of one hundred and fifty thousand dollars is hereby sanctioned and confirmed and the Governors and the City are hereby declared to have had full capacity and power to enter into such agreement and to transfer and accept respectively the interest of the City in the said hospital.

**3.**—(1) There shall be paid annually by the City to the Governors the sum of thirty-seven and a half cents per day or part of a day for each in-patient of the said hospital who is a resident of the city.

(2) The word “resident” in this section shall have the same meaning as in *The Hospitals Act*.

**4.** *The University of Alberta Hospital Act*, being chapter 60 of the Statutes of Alberta, 1922, is hereby repealed.

**5.** This Act shall come into force on the day upon which it is assented to.
