A BILL TO AMEND THE AGRICULTURAL
SOCIETIES ACT.

Department to Agricultural Societies—

1. for the encouragement of planting trees around homes,
maximum \$100.00; and
2. for corn shows, maximum \$300.00.

An Act to amend The Agricultural Societies Act.

(Assented to _____, 1925.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Agricultural Societies Act Amendment Act, 1925.*"

2. *The Agricultural Societies Act*, being chapter 158 of the Revised Statutes of Alberta, 1922, is amended as to section 33, subsection (1), thereof—

(a) by striking out the word "paragraph" where it occurs in the first line of the proviso to paragraph (d), and substituting therefor the word "section"; and

(b) by adding immediately after paragraph (d) as paragraphs (dd) and (ddd) the following:

"(dd) To each agricultural society or association of individuals holding a corn show with the permission of the Department and filing in the Department a return furnishing in respect of such show the same information as is required of a society by paragraphs (c), (d) and (e) of section 23 hereof, an amount equal to the amount actually paid out for prizes at such show, but not exceeding the sum of two hundred and fifty dollars, provided that any grant under this paragraph may be paid when the said return is filed with the Department";

"(ddd) To each agricultural society or association of individuals encouraging the planting of trees around homes, and filing in the Department a return furnishing in respect of such planting of trees the same information as is required by paragraphs (c), (d) and (e) of section 23 hereof, an amount equal to the amount actually paid out for prizes for the planting of trees, but not exceeding the sum of one hundred dollars."

(c) i. by adding in paragraph (g) after the words "field grain" the words "or sugar beet";

ii. by adding to the said paragraph the following proviso:

"Provided that in the case of a sugar beet field competition, the maximum sum payable for any one competition shall be seventy-five dollars."

3. This Act shall come into force on the day of 19...
