

# BILL

No. 29 of 1926.

An Act to amend The Private Hospitals Act.

(Assented to \_\_\_\_\_, 1926)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The Private Hospitals Act Amendment Act, 1926.*"

**2.** *The Private Hospitals Act*, being chapter 41 of the Statutes of Alberta, 1925, is amended by striking out section 3 thereof and substituting therefor the following:

**"3.** No private hospital shall be operated except under the authority of a license issued under this Act—

- (a) in cities by the local board of health; and
- (b) in towns, villages, municipal districts and improvement districts by the Provincial Board of Health."

**3.** Section 6 of the said Act is amended by inserting after the words "revoked by" where they occur in the first line thereof, the words "a local board, or by," and by inserting after the words "in the opinion of" where they occur in paragraph (c) thereof, the words "a local board, or of."

**4.** Section 7 of the said Act is amended by inserting after the words "approved by" the words "a local board or."

**5.** Section 8 of the said Act is amended by inserting after the words "Provided that" the words "a local board or."

**6.** Section 9 of the said Act is amended by inserting after the words "prescribed by" where they occur in paragraph (d) of subsection (1) thereof, the words "a local board or."

**7.** Section 10 of the said Act is amended by inserting after the words "inspection by" where they occur therein, the words "a local board or," and by striking out the word "board" in the last line thereof and substituting therefor the word "boards."

**8.** Section 10a is added to the said Act as follows:

**"10a.** Whenever a local board of health has granted or refused to grant or revoked a license or exercised any other

power under the provisions of this Act, an appeal shall lie from the decision of the board to the Provincial Board of Health, whose decision shall be final."

**9.** Section 13 of the said Act is amended by inserting after the words "forwarded to" where they occur therein, the words "a local board and."

**10.** Section 19 of the said Act is amended by inserting after the words "any member of" where they occur therein, the words "a local board or"; and by striking out the words "said board" and substituting therefor the words "said boards."

**11.** This Act shall come into force on the ..... day of .....19....
