An Act to Amend The Village Act, 1927.

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. This Act may be cited as "The Village Act, 1927, Amendment Act, 1928."
- 2. The Village Act, 1927, being chapter 54 of the Statutes of Alberta, 1927, is amended by adding as section 14a, immediately after section 14 thereof, the following:

"14a.—(1) The Minister may form into a summer village any summer resort, either of his own motion or upon

receipt of a petition.

- "(2) The petition shall fulfill the requirements set out in section 9, except that it must be signed by ten persons who, if the summer resort were erected into a village, would
- be upon the assessment roll thereof.

 "(3) When any summer resort is erected into a summer village, all the provisions of this Act shall apply to such summer village, except that-
 - "(a) only those persons who are on the assessment roll or who are entitled to be placed thereon, shall be placed upon the voters' list;
 - "(b) nomination day shall be the first Saturday in July and the election of councillors shall take place on the second Saturday in July;
 - the councillors shall assume office on the third Saturday of July at 7.30 p.m., and shall continue in office until their successors are elected;
 - "(d) three councillors shall be elected annually;
 - "(e) the appointment of an auditor shall be made before the first day of July in each year;
 - "(f) no summer village may issue debentures;
 - "(g) in order to qualify as an elector or councillor, no person shall be required to be a resident of the summer village.
- "(4) The council of any summer village shall have power to pass a by-law regulating the type and sea-worthiness of boats to be used on stretches of water within or adjacent to the boundaries of the village, and to license the owners thereof, and to regulate bathing and the disposal of refuse or other matter along the shores of any such stretch of water."

- 3. Section 127 of the said Act is amended—
 - (a) as to subsection (1) thereof, by striking out the words "and upon receipt of an authorization by the Board of Public Utility Commissioners, founded upon a petition signed by a majority of the resident electors, similar to that required by this Act, to authorise the issue of debentures by the village";
 - (b) by adding as subsection (1a) thereof, immediately after subsection (1), the following: "(1a) Before entering into the contract, the council shall pass a by-law authorising the same, which by-law shall in all respects be subject to the provisions of Part X, insofar as the same are applicable thereto."
- 4. Section 168 of the said Act is amended as to subsection (2) thereof, by adding thereto the following: "and immediately upon its completion, a copy thereof shall be posted up in the office of the secretary-treasurer."
- **5.** Section 246 of the said Act is amended by adding thereto, as subsection (2a) thereof, the following:
- "(2a) Buildings though not affixed to land so as to become part thereof, shall be considered as land for the purposes of assessment, and shall be assessed at the same rate as improvements affixed to land."
