- Hithe Legislative Assembly of the Province of Alberta, enacts as follows:
- This Act may be cited as "The Game Act Amendment Act, 1929."
- The Game Ant, being chapter 70 of the Revised Sistutes of Alberta, 1922, is assended as to section 2 thereof, by inserting at paragraph (ii) immediately after paragraph (i), the following:
 - "(ii) 'House' shall mean any shelter that has been constructed by a maskrat or better, for the purpose of feeding, resting or skepping therein."
 - Section 4 of the said Act is amended—
 (a) as to subsection (1) thereof, by adding thereto the
 - following paragraphs:

 "(f) any bear between the fifteenth day of June and the first day of Sentember:
 - "(g) any bear with a cub or cubs, at any time;
 "(k) any bear cub at any time"; and
 (b) by adding thereto the following new subsection:
- (5) by assuing increed the following new subsection:

 (5) No person shall deriving any one open season take or kill more than one of any species of bear."
 - Section 6 of the said Act is amended—
 as to subsection (1) thereof, by striking out paragraphs (c), (f) and (e) thereof; and
 - (b) by striking out subsection (7) thereof.

 5. Section 50s is added to the said Act immediately after
- section 80 thereof, as follows:

 Solar Whenever any licensee is convicted of an offence
 against any of the provisions of this Act, the convicting
 justice may direct that the said license shall be cancelled,
 and thereupon it shall be delivered to the convicting justice,
 to be forwarded to the Department, and no other license
 shall be issued to such licensee dering the curvent year."
