A BILL TO AMEND THE CO-OPERATIVE ASSOCIATIONS ACT.

This Bill provides for a completer method for winding up co-operative associations.

An Act to amend The Co-operative Associations Act.

(Assented to , 1929.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta,

enacts as follows:

1. This Act may be cited as "The Co-operating Associations Act Amendment Act, 1922."

The Co-operative Associations Act, being chapter 160
of the Revined Statutes of Alberts, 1922, is amouded by
starking out sections 22 and 23 thereof, and substituting
therefor the following:

"22.—(1) An association under this Act may be dissolved in either of the ways following, namely:

"(a) By filing with the registrar as instrument of dissolution, executed by not less than two-thirds of the numbers of the association, which shall contain—"(f) a statement that it is desirable to dissolve the
