

AN ACT TO AMEND "THE PURE BRED SIRES AREA ACT"

(Assented to 1929)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "The Pure Bred Sires Area Act, Amendment Act, 1929."
2. "The Pure Bred Sires Area Act", being Chapter 15 of the Statutes of Alberta 1928, is amended by inserting therein immediately after Section 9 thereof the following new Sections:

9a. The Council of any Municipal District, which is a municipal area, may pass a bylaw providing either for the guarantee by such district of the payment of the purchase price of any pure bred bull purchased by one or more persons resident in the Municipal District with the approval of and through the agency of the Minister, or for the purchase of any pure bred bulls by the council for resale to persons resident in the Municipal District.

9b. Every such bylaw shall before it is finally passed be submitted to a vote of the proprietary electors of the district in the same manner as is provided in the case of a money bylaw under The Municipal Districts Act 1926, and all the provisions of ~~that Act relating to the taking of~~ such a vote shall *mutatis mutandis* apply to the taking of a vote upon any bylaw under this Act.

9c. In the event of the Council of any district being called upon to pay or paying any money on account of any guarantee entered into pursuant to this Act, it shall be entitled by way of subrogation to all the securities, rights and remedies of the person entitled to the benefit of such guarantee.

9d. The Minister may make rules and regulations governing:

- (a) The manner in which any pure bred sire shall be acquired, and the terms and conditions upon which the same may be purchased and sold.
- (b) The nature and form of the guarantee.
- (c) The nature and extent of the security to be given upon the animal purchased, its offspring, or otherwise for the payment of the amount guaranteed.
- (d) The form of any bylaw under this Act.

9e. Upon the Council of Municipal District which has passed a bylaw under this Act for the purchase of pure bred bulls by the Council passing a resolution requesting the Minister to purchase any pure bred bulls for resale to the Council, the Minister may in his discretion purchase and resell to the Council any pure bred bulls upon such terms and conditions as to payment or otherwise as he may deem proper.
