Most Gracious Sovereign:

WHEREAS it appears by Messages from His Honour William Egbert, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the said Messages, that the sums hereinafter mentioned are required to defray certain expenses of the Public Service of Alberta not otherwise provided for during the financial periods ending respectively the thirty-first day of March, one thousand nine hundred and twenty-nine, the thirty-first day of March, one thousand nine hundred and thirty, and the thirty-first day of March, one thousand nine hundred and thirty-one, and for other purposes relating thereto:

May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, as follows:

1. This Act may be cited as "The Appropriation Act, 1930."

2. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole two hundred and thirty-two thousand, three hundred and fortyeight dollars and twenty-four cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand, nine hundred and twentyeight, to the thirty-first day of March, one thousand nine hundred and twenty-nine, not otherwise provided for and set forth in Schedule A to this Act.

3. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole one million, three hundred and sixty-eight thousand, two hundred and thirty dollars and five cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and twentynine, to the thirty-first day of March, one thousand nine hundred and thirty, not otherwise provided for and set forth in Schedule B to this Act.

4. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole twentynine million, eight hundred and forty-four thousand, five hundred and fifty dollars and fifty-eight cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty, to the thirty-first day of March, one thousand nine hundred and thirty-one, not otherwise provided for and set forth in Schedule C to this Act.

5. The due application of all moneys expended under this Act shall be accounted for.

6. This Act shall come into force on the day upon which it is assented to.
