HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows

 This Act may be cred as "The Dramage Districts Act, 1921, Amendment Act, 1831."

 The Drussage Dutivicts Act, 1922, hency chapter 46 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 2 thereof

- (a) as to paragraph (k) by straking out the same and by substituting therefor the following
 - *(b) "Minister' means the member of the Executive Council for the time being chaiged with the ediministration of the Act."
- (b) As to paragraph (p) of the sod sectors by striking not the expression "The Domainon Lend Surveys Act" and by sublishing threadow "The Domainon Land Surveys Act or any Act of the Legislature of the Province of Alberta relating to surveys"
- (c) As to paragraph (z) thereof by adding at the end "and any Act of the Legislature of the Province relating to serveys"

"34. The Board shall forthwith, after receipt of the engunear's preliminary repeat provided for in this Act, make application in accertance with the provisions of *The Water Resources Act* for the approval of the Minister."

5. The said Act is further amended as to section 35 thereof by striking out the same and by substituting therefor the following
