An Act to amend The Alberta Wheat Pool Act, 1929.

(Assented to _____, 1933.)

WHEREAS by sections 7 and 8 of *The Alberta Wheat Pool Act, 1929*, it is provided that the persons entitled to vote upon the matters therein mentioned shall be those members of the Alberta Wheat Pool (hereinafter called "the pool") who are at the time of voting holders of a current marketing agreement; and

Whereas under the current marketing agreement now subsisting between the pool and its members obligation to deliver wheat to the pool expires on the fifteenth day of July, A.D. 1933; and

Whereas it is not the present intention of the pool on account of prevailing difficult conditions to enter into a new agreement with its members requiring delivery of wheat for pooling for any specified period; and

Whereas it is necessary that provision be made as to the persons who shall be entitled to vote upon the matters aforesaid at any time at which there is no subsisting marketing agreement between the pool and its members requiring delivery of wheat for pooling for any specified period in order that the pool may continue to exercise its corporate powers and functions and carry on its business and affairs during any such time as last aforesaid; and

Whereas a petition has been presented by the pool praying that *The Alberta Wheat Pool Act, 1929*, be amended as is hereinafter set forth, and it is expedient to grant the prayer of the said petitioner;

Now therefore, His Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Alberta Wheat Pool Act, 1929, Amendment Act, 1933.*"

2. *The Alberta Wheat Pool Act, 1929*, being chapter 73 of the Statutes of Alberta, 1929, is hereby amended as to section 6 thereof by striking out the same and by substituting therefor the following:

"6. At any time during which there is a current marketing agreement the persons entitled to vote shall be those members who are then the holders of a current marketing

agreement and no others; at any time during which there is no current marketing agreement the persons then entitled to vote shall be those members who were entitled to vote immediately before the expiration of the period for delivery of wheat for pooling specified on the marketing agreement between the pool and its members which was last current."

3. The said Act is further amended as to section 7 thereof by striking out the words "A member who is at the time he attempts to vote the holder of a current marketing agreement shall be entitled to cast and vote in person" where the same occur therein and by substituting therefor the words "Every member who is at the time of voting entitled to vote may cast one vote in person."

4. The said Act is further amended as to section 8 thereof by striking out the words "the vote of the member who is at the time of that voting the holder of a current marketing agreement" where the same occur therein and by substituting therefor the words "the vote of any member who is at the time of voting entitled to vote."

5. This Act shall come into force on the day upon which it is assented to.
