

Bill No. 37 of 1933.

A BILL TO AMEND THE ALBERTA PHARMACEUTICAL ASSOCIATION ACT.

---

NOTE.

Section 2 of this Bill confers upon the association the power to assist any organization having for its objects the interests or welfare of members of the association.

Section 3 of the Bill strikes out the word "fees" in section 18 of the Act.

Section 4 of the Bill substitutes a judge of the Supreme Court for a judge of the District Court as the judge to hear appeals against the striking off by the Council of a member of the Association.

Section 5 of the Bill amends certain of the provisions of the Act as to the qualification for admission to the association and for the registration as members of the association of persons who are the members of similar associations elsewhere than in the Province of Alberta, and enables the council to decline to recognize any association which does not admit members of this association on equally favourable terms.

Section 6 of the Bill inserts in the Act an express prohibition against the sale by persons other than those persons who are expressly authorized so to do by the Act of poisons, drugs or medicines except patent medicines and except the drugs specified therein, but provides that nothing in the section is to prevent any person selling poisons, drugs or medicines at any point in the Province more than fifteen miles from the nearest place of business operated by a member of the association. Such persons are required to sell poisons subject to the regulations contained in the Act with reference thereto. This section further prohibits any person who is not a member of the association in good standing from using the title of "chemist" or similar titles calculated to lead people to believe that such person is registered under the Act.

# BILL

No. 37 of 1933.

An Act to amend The Alberta Pharmaceutical Association Act.

(Assented to \_\_\_\_\_, 1933.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The Alberta Pharmaceutical Association Act Amendment Act, 1933.*"

**2.** *The Alberta Pharmaceutical Association Act*, being chapter 203 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 3 thereof by adding at the end thereof the following new subsection:

"(3) The association shall also have power to assist any organization having for its objects or some of them the protection, advancement or promotion of the interests or welfare of the members of the association in such manner and in such amount as the council may from time to time determine."

**3.** The said Act is further amended as to section 18 thereof by striking out the word "fees" where the same occurs in subsection (3) thereof.

**4.** The said Act is further amended as to section 18*a* thereof by striking out the words "District Court" where the same occur in subsection (3) thereof, and by substituting therefor the words "Supreme Court."

**5.** The said Act is further amended as to section 24 thereof—

- (a) by striking out the word "or" where the same occurs at the end of clause (b) of subsection (1) thereof, and by substituting therefor the words "and that he is a British subject; or";
- (b) by striking out the words "twelve months of such apprenticeship have been served," where the same occur in subsection (3) thereof, and by substituting therefor the words "such apprenticeship has been served";

- (c) by striking out subsection (4) thereof and by substituting therefor the following:

“(4) Any British subject who is a registered licentiate in pharmacy of any pharmaceutical association or college of pharmacy approved by the council in Great Britain or Ireland, the Dominion of Canada, or the United States of America, may be registered as a member of the Alberta Pharmaceutical Association on producing to the University of Alberta satisfactory evidence that at the time such persons procured their licenses from any such college or association the educational requirements for such license were in all respects equivalent to those of the Alberta Pharmaceutical Association in respect of its own candidates at the time such licentiates apply for membership in the Alberta Pharmaceutical Association”;

- (d) by adding at the end thereof the following new subsection:

“(6) The council shall be entitled to refuse to approve for the purposes of the preceding subsections any pharmaceutical association or college of pharmacy which does not admit registered licentiates of this association on terms as favourable as those provided for the admission to this association of registered licentiates from other pharmaceutical associations or colleges of pharmacy.”

6. The said Act is further amended as to section 25 thereof by striking out subsection (1) thereof and by substituting therefor the following:

“25.—(1) (a) No person shall, save as herein provided, sell or keep open shop for retailing, dispensing, or compounding poisons, drugs or medicines, except patent or proprietary medicines, as defined by *The Proprietary or Patent Medicine Act*, being chapter 151 of the Revised Statutes of Canada, 1927, and except turpentine, Epsom salts, copperas, senna, alum, borax, castor oil, sulphur, Glauber's salt, cream of tartar, carbonate of soda, bicarbonate of soda, glycerine, carbonate of magnesia, citrate of magnesia, Rochelle salts, saltpetre, spirits of nitre, rhubarb root, solution of ammonia, phosphate of soda, gum camphor and chloride of lime:

Provided that nothing in this section contained shall prevent any person selling poisons, drugs or medicines at any point in the Province of Alberta more than fifteen miles from the nearest place of business operated by a member of the association: Provided further that all the other provisions of this Act in regard to the sale of poisons shall apply to any sale by any such persons.

- (b) No person shall assume or use the title of chemist and druggist, or chemist, or druggist, or pharmacist, or apothecary, or dispensing chemist, or dispensing druggist, drug store, drug dispensary, or other words of like import, or any sign, title or advertisement implying or calculated to lead people to infer that he is registered under this Act, and unless such person has taken out a certificate under the provisions of this Act for the time during which he is selling or keeping open shop for retailing, dispensing, or compounding poisons, drugs or medicines, or assuming or using such title."
