

BILL

No. 50 of 1933.

An Act for granting to His Majesty Certain Sums of Money for the Public Service for the Fiscal Years Ending Respectively the Thirty-first day of March, 1932, the Thirty-first day of March, 1933, and the Thirty-first day of March, 1934.

(Assented to _____, 1933.)

Most Gracious Sovereign:

WHEREAS it appears by Messages from His Honour, W. L. Walsh, Lieutenant Governor of the Province of Alberta, and the Estimates accompanying the said Messages, that the sums hereinafter mentioned are required to defray certain expenses of the Public Service of Alberta, not otherwise provided for, during the financial periods ending respectively the thirty-first day of March, one thousand nine hundred and thirty-two, the thirty-first day of March, one thousand nine hundred and thirty-three, and the thirty-first day of March, one thousand nine hundred and thirty-four, and for other purposes relating thereto:

May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, as follows:

1. This Act may be cited as "*The Appropriation Act, 1933.*"

2. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole one hundred and seventy-five thousand, three hundred dollars and thirty-nine cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-one, to the thirty-first day of March, one thousand nine hundred and thirty-two, not otherwise provided for and set forth in Schedule A to this Act.

3. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole two million, nine hundred and fifty-three thousand, seven hundred and sixty-six dollars and seven cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-two, to the thirty-first day of March, one thousand nine hundred and thirty-three, not otherwise provided for and set forth in Schedule B to this Act.

4. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole twenty million, one hundred and twelve thousand, two hundred and eighty-nine dollars and sixty-eight cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-three to the thirty-first day of March, one thousand nine hundred and thirty-four, not otherwise provided for and set forth in Schedule C to this Act.

5. The due application of all moneys expended under this Act shall be accounted for.

6. This Act shall come into force on the day upon which it is assented to.
