A BILL RESPECTING CERTAIN IRRIGATION RATES
AND DRAINAGE RATES.

NOTE.

By this Bill provision is made for the cancellation of penalties on irrigation rates and drainage rates in arrear as at the first day of January in the years 1932 and 1933 upon the payment of the arrears together with a sum by way of penalty of 5% on the arrears in the years 1932 and 1933 respectively, and for the allowance of a discount in respect of the rates levied in the years 1932 and 1933 of 5% if paid before the first day of November and of 2½% if paid before the fifteenth day of December of the year in which they are levied.

An Act respecting certain Irrigation Rates and Drainage Rates.

(Assented to _____, 1933.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Irrigation Rates and Drainage Rates Penalties Act.*"

2. Notwithstanding any of the provisions of *The Irrigation Districts Act* or of *The Drainage Districts Act*, the board of trustees of any irrigation district and of any drainage district may by by-law authorize the cancellation of the whole or any part of all penalties which have been previously added to rates in arrear as at the first day of January, 1932, or the first day of January, 1933, upon the payment in the case of the rates in arrear as at the first day of January, 1932, in the year 1932, and in the case of rates in arrear as at the first day of January, 1933, in the year 1933, of a sum by way of penalty equal to five per centum of the amount of rates originally levied and so in arrear, and upon making any such by-law or order it shall be provided that there shall be allowed a discount for prompt payment of taxes levied in the year 1932 of five per centum if paid before the first day of November in that year, or two and one-half per centum if paid after the said first day of November and on or before the fifteenth day of December in the year 1932, and a discount for prompt payment for taxes levied in the year 1933 of five per centum if paid before the first day of November in that year, and two and one-half per centum if paid after the said first day of November and on or before the fifteenth day of December in the year 1933.

3. This Act shall come into force on the day upon which it is assented to, and upon coming into force shall be deemed to have been in force at all times from and after the sixth day of April, 1932.
