### Bill No. 57 of 1934.

#### A BILL TO AMEND THE SCHOOL GRANTS ACT.

#### NOTE.

By this Bill the grant payable under section 6 to consolidated districts for conveying pupils to and from school is reduced from \$1.50 to \$1.25. (Section 2.)

By section 3 the maximum grant in aid of technical education is reduced to \$540.

Section 4 provides that the aggregate grants payable in any year to any school district in respect of any one room under section 26a shall not exceed 75% of the salary paid for the instruction given in that room.

The amendment made by section 5 is consequential on the transfer to the Province of its natural resources.

An Act to amend The School Grants Act.

- HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:
- 1. This Act may be cited as "The School Grants Act Amendment Act, 1934."
- 2. The School Grants Act, being chapter 53 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 6 thereof by striking out the words "one dollar and fifty cents," where the same occur in paragraph (c) thereof, and by substituting therefor the words "one dollar and twenty-five cents"
- **3.** The said Act is further amended as to section 8 thereof by striking out the words "six hundred dollars," where the same occur in paragraph (a) thereof, and by substituting therefor the words "five hundred and forty dollars."
- **4.** The said Act is further amended as to section 26a thereof by adding at the end thereof the following new subsections:
- sections:

  "(7) The aggregate amount of all grants payable in any year under this Act to any school district in respect of any one room, shall not in any case exceed seventy-five per centum of the amount paid for salary to the teacher or teachers for the instruction given in that room during the year in respect of which the grant is payable.
- "(8) No grant shall be payable under this section in respect of any room for which the district receives a grant under any of the paragraphs (c), (d) and (e) of section 4."
- 5. The said Act is further amended as to section 31 thereof by inserting therein, immediately after the words "from the Government of Canada," where the same occur therein, the words "or under *The Provincial Lands Act.*"
- ${\bf 6.}$  This Act shall come into force on the day upon which it is assented to.
