No. 7 of 1935.

An Act for Granting to His Majesty Certain Sums of Money for the Public Service for the Fiscal Years Ending respectively the Thirty-first day of March, 1934, the Thirty-first day of March, 1935, and the Thirty-first day of March, 1936.

(Assented to _____, 1935.)

Most Gracious Sovereign:

WHEREAS it appears by Messages from the Honourable the Administrator of the Government of the Province of Alberta, Horace Harvey, and the Estimates accompanying the said Messages, that the sums hereinafter mentioned are required to defray certain expenses of the Public Service of Alberta, not otherwise provided for, during the financial periods ending respectively the thirty-first day of March, one thousand nine hundred and thirty-four, the thirty-first day of March, one thousand nine hundred and thirty-five, and the thirty-first day of March, one thousand nine hundred and thirty-six, and for other purposes relating thereto:

May it therefore please Your Majesty that it may be enacted, and be it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, as follows:

1. This Act may be cited as "*The Appropriation Act, 1935.*"

2. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole one hundred and thirty-six thousand, six hundred and ninety-five dollars and seventy-three cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-three to the thirty-first day of March, one thousand nine hundred and thirty-four, not otherwise provided for and set forth in Schedule A to this Act.

3. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole five million, three hundred and forty-seven thousand, seven hundred and three dollars and twenty-three cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-four to the thirty-first day of March, one thousand nine hundred and thirty-five, not otherwise provided for and set forth in Schedule B to this Act.

4. From and out of the General Revenue Fund there may be paid and applied a sum not exceeding in the whole twenty-three million, eight hundred and seventy-six thousand, eight hundred and seventy-nine dollars and ninety-seven cents towards defraying the several charges and expenses of the Public Service from the first day of April, one thousand nine hundred and thirty-five to the thirty-first day of March, one thousand nine hundred and thirty-six, not otherwise provided for and set forth in Schedule C to this Act.

5. The due application of all moneys expended under this Act shall be accounted for.

6. This Act shall come into force on the day upon which it is assented to.
