A BILL TO AMEND THE TAX CONSOLIDATION  
ACT, 1927.

NOTE.

The amendment made by section 2 of this Bill to The Tax Consolidation Act, 1927, makes the references in the Act to the Director under The Debt Adjustment Act applicable to any person or body having for the time being the general supervision of any statute of the Province relating to debt adjustment.

By section 3 of the Bill a number of statutes passed subsequently to 1927 are included in Schedule B to the amended Act so that indebtedness under any of those statutes may be dealt with pursuant to the Act.

## BILL

No. 35 of 1935.

An Act to amend The Tax Consolidation Act, 1927.

(Assented to \_\_\_\_\_, 1935.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The Tax Consolidation Act, 1927, Amendment Act, 1935.*"

**2.** *The Tax Consolidation Act, 1927*, being chapter 52 of the Statutes of Alberta, 1927, is hereby amended as to section 2 thereof by adding at the end thereof the following new subsection:

"(2) The references in this Act to 'the Director having the general supervision and administration of *The Debt Adjustment Act*,' and to 'the Director' shall be deemed to refer to any person or body having for the time being the general supervision and administration of any statute of the Province relating to the adjustment of indebtedness."

**3.** The said Act is further amended as to Schedule B thereof by adding at the end thereof the following:

"**12.** *The Temporary Seed Grain Advances Act, 1931*, being chapter 58 of the Statutes of Alberta, 1931.

"**13.** *The Temporary Seed Grain Advances Act, 1931, Amendment Act, 1932*, being chapter 32 of the Statutes of Alberta, 1932.

"**14.** *The Fodder Relief Act*, being chapter 30 of the Statutes of Alberta, 1932.

"**15.** *The Temporary Seed Grain Advances Act, 1934*, being chapter 19 of the Statutes of Alberta, 1934.

"**16.** *The Feed Grain and Fodder Advances Act, 1934*, being chapter 23 of the Statutes of Alberta, 1934."

**4.** This Act shall come into force on the day upon which it is assented to.
