# A BILL FOR THE AMENDMENT AND CONTINUATION OF THE TEMPORARY SEED GRAIN ADVANCES ACT, 1934.

#### NOTE.

The effect of the amendments made by this Bill is to extend the operation of *The Temporary Seed Grain Advances Act, 1934*, to the year 1935, and to permit the making of advances of rye and of seed grain required for reseeding when that is necessary by reason of crop damage caused by wind or insects, to be made after the fifteenth day of May of each of the years 1934 and 1935.

The Bill extends to advances of seed required for reseeding made in 1935.

# BILL

No. 42 of 1935.

An Act for the amendment and continuation of The Temporary Seed Grain Advances Act, 1934.

(Assented to

, 1935.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. This Act may be cited as "The Temporary Seed Grain Advances Act, 1934, Continuation Act."
- 2. The Temporary Seed Grain Advances Act, 1934, being chapter 19 of the Statutes of Alberta, 1934, is hereby amended as to section 8 thereof—
  - (a) by striking out paragraph (a) thereof and by substituting therefor the following:
    - "(a) No seed grain shall be so purchased or distributed after the fifteenth day of May, 1934, for seeding in that year, or after the fifteenth day of May, 1935, for seeding in that year, except rye and except seed grain required for the purpose of reseeding land in cases where reseeding is necessary by reason of damage caused by wind or by insects."; and
  - (b) by striking out the words "in the case of any applicant", where the same occur in paragraph (b) thereof, and by substituting therefor the words "in the case of any one applicant and in any year"; and
  - (c) by striking out the words and figures "in each of the years 1934 and 1935", where the same occur in paragraph (f) thereof, and by substituting therefor the words and figures "in each of the years 1934, 1935 and 1936"; and
  - (d) by striking out the words and figures "on or before July 31st, 1934", where the same occur in paragraph (f) thereof and by substituting therefor the words and figures "on or before the thirty-first day of July, 1934, in the case of advances made before the fifteenth day of May, 1934, and within ninety days after the date of making the advance in the case of all other advances,".
- ${\bf 3.}$  The said Act is further amended as to section 12 thereof—
  - (a) by striking out the words "shall be enforceable by seizure and sale thereof and such charge," where the same occur therein;

- (b) by adding at the end thereof the following new sub-
  - "(2) For the purpose of enforcing the payment of any moneys which are a lien upon crops, the municipality is empowered to levy a distress upon such crops and to proceed to sell the distress so levied in the same manner as if the said moneys were taxes which the municipality is authorized by statute to
- 4. The said Act is hereby continued in force for the year 1935, and shall, in relation to the operation thereof in the year 1935, be read and construed as if any reference in sections 3, 4, 5, 8, 11 and 17 and in the schedule to any of the years 1934, 1935 and 1936 was, in each case, a reference to the next ensuing year.
- 5. This Act shall come into force on the day upon which it is assented to, and upon it so coming into force the amendment made by section 2 of this Act shall be deemed to have been in force at all times from and after the twenty-first day of March, 1934.
