# BILL

No. 79 of 1935.

An Act respecting certain Borrowings by the Province for  
Unemployment and Agricultural Relief.

(Assented to \_\_\_\_\_, 1935.)

**H**IS MAJESTY, by and with the advice and consent of  
the Legislative Assembly of the Province of Alberta,  
enacts as follows:

**1.** This Act may be cited as "*The Unemployment and Agricultural Relief Borrowings Act.*"

**2.** The borrowings by the Government of the Province from the Government of Canada made for the purposes of unemployment and agricultural relief in the year 1934, amounting in the aggregate to the sum of \$2,145,000.00, particulars whereof are set out in the schedule hereto, and orders in council and the treasury bills given in respect thereof are each hereby confirmed, ratified and validated, and the said borrowings and treasury bills may from time to time be renewed or refunded in such manner and for such periods of time as to the Lieutenant Governor in Council may seem proper.

**3.** This Act shall come into force on the day upon which it is assented to.

## SCHEDULE.

- (1) \$645,000.00 4½% one year Province of Alberta Treasury Bills dated September 15th, 1934, authorized under Order in Council numbered 770-34, and raised for the purpose of extending relief to farmers in the Province of Alberta by way of loans to enable seeding operations for the 1934 crop season to be carried on including the purchase of seed grain and fodder.
- (2) \$750,000.00 4½% one year Province of Alberta Treasury Bills dated September 24th, 1935, authorized under Order in Council numbered 820-34, and raised for the purpose of reloaning to the Cities of Edmonton, Calgary and Lethbridge for current and relief purposes.
- (3) \$750,000.00 4½% one year Province of Alberta Treasury Bills dated December 20th, 1934, authorized under Order in Council numbered 1125-34, for the purposes of agricultural relief.
