A BILL TO AMEND THE LOCAL AUTHORITIES'
BORROWINGS GUARANTEE ACT.

NOTE.

This Bill extends the provisions of the Act for an additional year and adds to the cases in which a guarantee may be given under the Act sums which a municipal district is liable to pay to a municipal hospital board or to the board of any hospital for the hospitalization of its residents.

An Act to amend The Local Authorities' Borrowings
Guarantee Act.

(Assented to _____, 1936.)

HIS MAJESTY, by and with the advice and consent of
the Legislative Assembly of the Province of Alberta,
enacts as follows:

1. This Act may be cited as "*The Local Authorities' Borrowings Guarantee Act Amendment Act, 1936.*"

2. *The Local Authorities' Borrowings Guarantee Act*, being chapter 56 of the Statutes of Alberta, 1934, is hereby amended as to section 2 thereof,—

- (a) by striking out the words and figures "years 1934, 1935 and 1936", where the same occur therein, and by substituting therefor the words and figures "years 1934, 1935, 1936 and 1937";
- (b) by striking out the words and figures "first day of April, 1936", where the same occur therein, and by substituting therefor the words and figures "first day of April, 1937"; and
- (c) by striking out the words "for the purpose of meeting the current expenditures of a municipal district, for the purpose of meeting the current expenditures of a school district, and for the purpose of enabling a municipal district to pay the requisitions of any school district within the municipal district; and may prescribe as to the nature, extent and form of any guarantee to be so given", where the same occur therein, and by substituting therefor the words "for the purpose of meeting the expenditures of a municipal district, for the purpose of meeting the expenditures of a school district, and for the purpose of enabling a municipal district to pay the requisitions of any school district within the municipal district or any sum which a municipal district is liable to pay to a municipal hospital board or to the board of any hospital for the hospitalization of residents of the municipal district; and may prescribe as to the nature, extent and form of any guarantee to be so given."

3. The said Act is further amended as to section 3a thereof,—

- (a) by striking out the words and figures "the years 1935 and 1936", where the same occur therein, and by substituting therefor the words and figures "the years 1935, 1936 and 1937"; and

- (b) by striking out the words and figures "first day of April, 1936", where the same occur therein, and by substituting therefor the words and figures "first day of April, 1937".

4. The said Act is further amended as to section 4 thereof,—

- (a) by striking out the words and figures "in the years 1935, 1936 and 1937", where the same occur therein, and by substituting therefor the words and figures "in the years 1935, 1936, 1937 and 1938"; and
- (b) by striking out the words and figures "April, 1935, or between the thirty-first day of March, 1935, and the first day of April, 1936, as the case may be", where the same occur therein, and by substituting therefor the words and figures "April, 1935, or between the thirty-first day of March, 1935, and the first day of April, 1936, or between the thirty-first day of March, 1936, and the first day of April, 1937, as the case may be".

5. This Act shall come into force on the day upon which it is assented to.
