# A BILL TO AMEND THE CO-OPERATIVE ACTIVITIES SUPERVISION ACT.

#### NOTE.

By section 2 the Supervisor of Co-operative Activities is required to examine into and either approve or disapprove applications for the incorporation of societies under *The Alberta Co-operative Rural Credit Act*.

Section 3 prohibits the incorporation of any association under *The Co-operative Marketing Associations Act* or the incorporation of any society under *The Alberta Co-operative Rural Credit Act*, without the approval of the Minister; and such approval is given on the favourable report of the Supervisor.

Section 4 empowers the Minister to suspend or cancel the charter of any Co-operative Association or Co-operating Marketing Association in case of mismanagement.

An Act to amend The Co-operative Activities Supervision  ${\bf Act.}$

- HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:
- 1. This Act may be cited as "The Co-operative Activities Supervision Act Amendment Act, 1937."
- 2. The Co-operative Activities Supervision Act, being chapter 5 of the Statutes of Alberta, 1928, is hereby amended as to section 4 thereof,—
  - (a) by inserting therein immediately after paragraph
    - (a):

      "(a1) To examine all applications for the incorporation of any society under The Alberta Co-operative Rural Credit Act, and the conditions under which the society will operate; to confer with and advise the persons promoting the society as to its formation and organization, and having regard to the result of enquiries made by him, to approve or refuse to approve any such application."
  - (b) by striking out clause (i) of paragraph (e) thereof.
- 3. The said Act is further amended by inserting therein immediately after section 4 the following new section:
- "4a.—(1) No association and no society under *The Alberta Co-operative Rural Credit Act* shall be incorporated until the incorporation is approved by the Minister pursuant to this section.
- "(2) In case it is made to appear to the Minister by the report of the Supervisor, that it is desirable and proper so to do, the Minister may approve in writing the incorporation of an association or a society under *The Alberta Cooperative Rural Credit Act.*"
- 4. The said Act is further amended as to section 5 by striking out the words "he may in his discretion" where the same occur therein and by substituting therefor the words "he may in his discretion suspend or cancel the charter of the association or may".
- 5. This Act shall come into force on the day upon which it is assented to.
