A BILL TO AMEND THE STOCK INSPECTION ACT,  
1922.

NOTE.

The amendment made by section 2 revises the provisions relating to the inspection of cattle at public stock yards and abattoirs.

Subject to the other provisions of the section, all stock brought into a place at which there is an inspector and which is a public stock yard or abattoir, or a place in which stock is held for shipment out of the Province, is required to be placed in locked pens and to be inspected before removal.

No inspection is required in the case of stock being moved from point to point in the Province which is brought into a public stock yard at Calgary or Edmonton for rest and feed and is kept in locked pens and has not been offered for sale.

No inspection fee is payable for the inspection of feeder cattle on removal from a public stock yard for feeding and finishing.

No inspection fee is payable in respect of stock brought into an abattoir if the same has been inspected on the day it is brought into the abattoir and the inspection fee has been paid.

Section 3 of the Bill amends section 7 of the Act and requires the giving of notice by mail or telegraph to the Live Stock Commissioner or the local brand inspector of every proposed shipment of live stock out of the Province; such notice is to reach the Commissioner or inspector at least two clear days before the proposed date of shipment.

# BILL

No. 39 of 1938.

An Act to amend The Stock Inspection Act, 1922.

(Assented to \_\_\_\_\_, 1938.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Stock Inspection Act, 1922, Amendment Act, 1938.*"

2. *The Stock Inspection Act, 1922*, being chapter 69 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 3 by striking out the same and by substituting therefor the following:

"3.—(1) Except only where it is otherwise provided by this section, all stock brought into any place at which there is an inspector and which is a public stock yard or abattoir or a place in which stock is held for sale or shipment out of the Province, shall be placed immediately in pens which shall be securely locked and shall be inspected by an inspector and shall not be removed from such place until same has been duly inspected and the fees for such inspection have been paid.

"(2) Where stock which is being moved from point to point within the Province is brought into any public stock yard at Edmonton or Calgary to be held for rest and feed and such stock has been kept in locked pens and has not been offered for sale during the time that same was so held, no inspection shall be made.

"(3) Where upon the removal of any feeder cattle from any public stock yard at which the same has been purchased, the purchaser certifies in writing to the inspector that such feeder cattle are to be placed immediately in feed lots and finished as beef, no fee shall be payable in respect of the inspection made upon such removal.

"(4) No fee shall be payable in respect of any stock brought into an abattoir if it is shown by a certificate of inspection that such stock has been inspected on the day upon which it is brought into the abattoir and the fee for such inspection has been paid."

3. The said Act is further amended as to section 7 by striking out subsection (1) and by substituting therefor the following:

“(1) Every person who proposes to ship stock out of the Province shall advise the Live Stock Commissioner or the local brand inspector by mail or telegraph of the proposed shipment, setting out the places at which they are to be shipped from and the destination. Such notice shall be sent to the local brand inspector or the Live Stock Commissioner, as the case may be, so that it will reach either at least two clear days before the proposed date of shipment.”

4. This Act shall come into force on the day upon which it is assented to.
