Bill No. 48 of 1938.

A BILL TO PROVIDE FOR THE RESTRICTION OF THE ACTIVITIES OF DAIRY CO-OPERATIVES TO PRESCRIBED AREAS.

NOTE.

This Bill applies to any association formed under The Co-operative Marketing Associations Act which has for its chief object the processing and/or dealing in cream, milk and/or butter fat, and defines such associations as Dairy Co-operatives.

Section 3 provides for the defining of any area of the Province as an area within which any Dairy Co-operative named in the order may purchase cream or butter fat or milk, whether for sale as fluid milk, fluid cream or for manufacture into butter, cream, ice cream or condensed milk.

Section 5 provides that so long as any order is in effect the Dairy Co-operative named in the order shall not purchase cream, butter fat or milk elsewhere in the Province for sale as fluid milk or fluid cream or for manufacture into butter, cream, ice cream or condensed milk elsewhere in the Province than in the area defined in the order; and no Dairy Co-operative other than the Dairy Co-operative named in the order is to purchase cream, butter fat or milk at any place within the area defined in the order for sale as fluid milk or fluid cream; and no Dairy Co-operative other than the Dairy Co-operative named in the order is permitted, within the area defined in the order, directly or indirectly, to operate any plan or place for the purpose of the reception thereat of any fluid milk or cream or for the purpose of manufacture of fluid milk, fluid cream or butter fat into butter, cream, ice cream or condensed milk.

Section 6 provides that every Dairy Co-operative which contravenes any of the provisions of section 5 shall be guilty of an offence and liable to a fine of not more than five hundred dollars.

Section 7 provides that nothing in the Act shall prevent any Dairy Co-operative from purchasing cream, milk or butter fat from any other Dairy Co-operative.

An Act to provide for the Restriction of the Activities of the Dairy Co-operatives to Prescribed Areas.

(Assented to , 1938.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "The Dairy Co-operatives Zones Act."

2. In this Act "Dairy Co-operative" means an association formed under *The Co-operative Marketing Associations Act*, which has for its chief object the processing and/or dealing in cream, milk and/or butter fat.

3. Upon the recommendation of the Minister of Trade and Industry, the Lieutenant Governor in Council may from time to time, by order, define any area of the Province as the area within which any Dairy Co-operative named in the order may purchase cream or butter fat or milk, whether for sale as fluid milk, fluid cream or for manufacture into butter, cream, ice cream or condensed milk.

4. Every such order shall be published in *The Alberta Gazette* and shall take effect either upon such publication or upon such date subsequent thereto as may be fixed in the order as the date upon which the same takes effect.

5. So long as any order made pursuant to this Act is in effect,—

- (a) the Dairy Co-operative named in the order shall not purchase cream, butter fat or milk elsewhere in the Province than in the area defined in the order for sale as fluid milk or fluid cream or for the manufacture into butter, cream, ice cream or condensed milk;
- (b) no Dairy Co-operative other than the Dairy Cooperative named in the order shall purchase cream, butter fat or milk at any place within the area defined in the order for sale as fluid milk or fluid cream;
- (c) no Dairy Co-operative other than the Dairy Cooperative named in the order shall, within the area defined in such order, directly or indirectly, have,

operate or maintain any plant or place for the purpose of the reception thereat of any fluid milk or cream or for the purpose of the manufacture of fluid milk, fluid cream or butter fat, into butter, cream, ice cream or condensed milk.

6. Every Dairy Co-operative which contravenes any of the provisions of section 5 shall be guilty of an offence and liable on summary conviction therefor to a fine of not more than five hundred dollars and costs.

7. Nothing in this Act shall prevent any Dairy Cooperative from purchasing cream, milk or butter fat from any other Dairy Co-operative.
