A BILL TO AMEND THE SUPERANNUATION ACT.

NOTE.

The amendment made by section 2 permits the inclusion of any continuous service on or before the first of July, 1922, in computing the term of continuous employment of a civil servant, for the purpose of ascertaining whether or not such civil servant is entitled to superannuation.

Section 3 provides for the delivery to the Civil Service Commissioner of a birth certificate or other evidence of the date of birth, by employees employed as at the thirty-first day of December, 1938, on or before that date and by persons becoming employees after that date, as soon as possible after the commencement of the employment. It further empowers the Superannuation Board, in cases where there has been any misstatements as to age, to make adjustments in fixing the amount of the annuity payable or direct the repayment to the employee the amount of the statutory deduction without interest, in satisfaction of his claim.

# BILL

No. 68 of 1938.

An Act to amend The Superannuation Act.

(Assented to \_\_\_\_\_, 1938.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The Superannuation Act Amendment Act, 1938.*"

**2.** *The Superannuation Act*, being chapter 8 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 10 by striking out subsection (1a) thereof and by substituting therefor the following:

"(1a) Any continuous service prior to and including the first day of July, 1922, during which a person was in the employ of the Government, shall be counted as service of that person as an employee within the meaning of this Act."

**3.** The said Act is further amended by inserting therein immediately after section 15 the following new section:

"**15a.**—(1) Every employee of the Government shall furnish the Civil Service Commissioner with a birth certificate setting out the date of birth, or in case such a certificate is not procurable, by delivering to him a statutory declaration made by a person having sufficient knowledge of the facts stated therein.

"(2) Such certificate or declaration as the case may be, shall be delivered to the Civil Service Commissioner by persons being employees in the employment of the Government as at the thirty-first day of December, 1938, on or before that date and by persons becoming employees on or after that date as soon as possible after they so become employed.

"(3) In any case where the Board is satisfied, after making due inquiry, that an employee has made any mis-statement as to the date of his birth in the statement furnished by him for the purpose of the Superannuation Board, the Board may in its discretion reduce the amount of the annuity otherwise payable or direct the repayment to such employee of the amount of the statutory deductions from his salary, without interest, and upon the payment of that amount to the employee his right to any benefit under this Act shall cease."

**4.** This Act shall come into force on the day upon which it is assented to.
