AN ACT TO AMEND THE GARAGEMEN'S LIEN ACT.

NOTE.

This Bill amends section 4 of *The Garagemen's Lien Act* by requiring the claim of lien to be filed in the office of the Provincial Secretary at Edmonton, instead of in the office of the Clerk of the Court in each of the Judicial Districts of Calgary and Edmonton, and by fixing the fee for such filing at twenty-five cents.

The Schedule to the Act is amended by providing a new form of claim of lien which calls for essential information which was not required by the original form.

An Act to amend The Garagemen's Lien Act.

(Assented to _____, 1938)

HIS MAJESTY, by and with the advice and consent of the
Legislative Assembly of the Province of Alberta,
enacts as follows:

1. This Act may be cited as "*The Garagemen's Lien Act
Amendment Act, 1938.*"

2. *The Garagemen's Lien Act*, being chapter 77 of the
Statutes of Alberta, 1937, is hereby amended as to section
4 by striking out the same and by substituting therefor the
following:

"4.—(1) Every such lien shall cease and determine on
the thirty-sixth day after the day upon which the storage for
which the lien is claimed terminated, or the day upon which
the motor vehicle was last serviced or the repairs were com-
pleted or the accessories were furnished, as the case may be,
unless before the last mentioned day the garageman files or
causes to be filed a claim of lien which shall be in Form A in
the Schedule to this Act in the office of the Provincial Secre-
tary, Government Buildings, Edmonton.

"(2) The fee payable on each such filing shall be twenty-
five cents."

3. The said Act is further amended as to the Schedule by
striking out Form A and by substituting therefor the
following:

Lien Act, claims a lien upon a certain vehicle (here set out

of the storage, servicing, repair, maintenance or accessories)
in respect of which the lien is claimed, the date upon which
the storage terminated or the motor vehicle was last serviced
or the repairs were completed, as the case may be (also insert
the name and address of the person who authorized such
storage, servicing or repairs).

4. This Act shall come into force on the day upon which
it is assented to.
