A BILL TO AMEND THE OLD AGE PENSIONS ACT, ALBERTA, AND TO CONFIRM, RATIFY AND VALIDATE CERTAIN ORDERS IN COUNCIL MADE IN PURSUANCE THEREOF.

NOTE.

The effect of the amendment made by section 2 is to place pensions to blind persons on the same footing as old age pensions with respect to the liability of the municipality, in which a pensioner lives to contribute ten per cent of the amount of the pension.

Section 3 validates and confirms all the orders in council which have been made under *The Old Age Pensions Act*, *Alberta*.

An Act to amend The Old Age Pensions Act, Alberta, and to Confirm, Ratify and Validate certain Orders in Council made in pursuance thereof.

(Assented to , 1938.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "The Old Age Pensions Act, Alberta, Amendment Act, 1938."

2. The Old Age Pensions Act, Alberta, being chapter 24 of the Statutes of Alberta, 1929, is hereby amended as to section 6 by adding at the end thereof the following new subsection:

"(7) For the purposes of this section 'Pension' means any pension payable under the provisions of the Dominion Act or the scheme hereinafter referred to, which are old age pensions or are pensions payable to blind persons; and 'Pensioner' means any person in receipt of an old age pension or a pension for blindness."

3.
