An Act to Amend The Alberta Wheat Pool Act, 1929.

(Assented to _____, 1939.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Alberta Wheat Pool Act, 1929, Amendment Act, 1939.*"

2. *The Alberta Wheat Pool Act, 1929*, being chapter 73 of the Statutes of Alberta, 1929, is hereby amended as to section 6 by striking out the same and by substituting therefor the following:

6. Any person who has made application to the Board of Directors in writing in such form and upon such conditions as may be from time to time prescribed by the Board of Directors for membership in the Pool may be declared by the Board of Directors to be a member of the Pool if,—

"(a) he is a grower of grain or the owner, purchaser, share crop purchaser or vendor, lessor, or lessee of farm lands capable of producing grain; and

"(b) he is not a member of the Pool under section 5 of this Act; and

"(c) he has between the first day of August, 1935, and the date of his application for membership delivered to the Pool or to the elevator facilities of Alberta Pool Elevators Limited five hundred bushels of grain or such other amount of grain as may be determined from time to time by a resolution passed by the delegates at an annual or a special meeting; and

"(d) he has acquired the ownership of an interest in the commercial or elevator reserves or both totaling twenty-five dollars."

3. The said Act is further amended as to section 7 by striking out the same and by substituting therefor the following:

7. Any person who at the time of voting is a member of the Pool under section 5 hereof or has been declared by the Board of Directors to be a member under section 6 hereof shall be entitled to cast one vote in person,—

"(a) on the election of any delegate for that member's sub-district;

“(b) on the recall of any delegate for that member’s sub-district;

“(c) on any referendum made under the by-laws.”

4. The said Act is further amended as to section 14 by adding at the end thereof the following new subsection:

“(2) If at any election of a director by the delegates of a district, an equal number of votes are cast for the candidates receiving the most votes thereat, the delegates shall report the result of such vote to the general annual meeting of the delegates then in session, and the director for such district for the ensuing year shall be elected by the delegates in attendance at such general meeting.”

5. This Act shall come into force on the day upon which it is assented to.
