A BILL RESPECTING PENALTIES FOR NON-PAY-MENT OF CERTAIN IRRIGATION RATES AND DRAINAGE RATES.

NOTE.

By this Bill the Boards of Trustees of irrigation districts and drainage districts are empowered by by-law to cancel penalties on rates in arrear as at the 1st January, 1939, upon the payment of five per cent on the amount of the arrears by way of penalty; and any such by-law must provide for a discount for prompt payment of rates levied in 1939 of five per cent if paid on or before the 1st November in that year or of two and one-half per cent if paid after that date and on or before the 15th December, 1939.

The Lieutenant Governor in Council is empowered to prescribe the by-law and to require the same to be enacted either by all boards of trustees or any specified board or boards.

An Act respecting Penalties for Non-Payment of Certain Irrigation Rates and Drainage Rates.

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. This Act may be cited as "The Irrigation Rates and Drainage Rates Penalties Act, 1939."
- 2. For the purposes of this Act, the expression "rates" means all rates levied by an irrigation district pursuant to The Irrigation Districts Act, and all drainage rates levied by a drainage district pursuant to The Drainage Districts Act, which are in arrear.
- 3.—(1) Notwithstanding any of the provisions of The Irrigation Districts Act or of The Drainage Districts Act, the board of trustees of any irrigation district and of any drainage district may by by-law authorize the cancellation of the whole or any part of the penalties which have been previously added to rates in arrear as at the first day of January, 1939, upon the payment in the year 1939 of a sum by way of penalty equal to five per centum of the amount of the rates originally levied and so in arrear, and upon making any such by-law it shall be provided that there shall be allowed a discount for prompt payment of rates levied in 1939 of five per centum if paid on or before the first day of November in that year, or two and one-half per centum if paid after the first day of November and on or before the fifteenth day of December, 1939.
- (2) The Lieutenant Governor in Council, may, upon the recommendation of the Irrigation Council, by order, prescribe the by-law to be passed by all such boards of trustees, or by any specified board or boards, and upon the making of any such order by the by-law so prescribed shall be enacted by every board required by the order to enact the same, and every by-law so enacted shall supersede any by-law passed by the Board under the provisions of subsection (1)
- 4. This Act shall come into force on the day upon which it is assented to.
