A BILL TO AMEND THE AGRICULTURAL RELIEF
ADVANCES ACT, 1938.

NOTE.

This Bill amends sections 12 and 13 of *The Agricultural Relief Advances Act, 1938*, and extends the lien to secure a repayment of an advance to all crops grown on all the lands of the recipient.

Section 15 is amended so as to make its provisions applicable to advances made under *The Agricultural Relief Advances Act* which was repealed in 1938.

An Act to Amend The Agricultural Relief Advances Act,
1938.

(Assented to _____, 1939.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Agricultural Relief Advances Act, 1938, Amendment Act, 1939.*"

2. *The Agricultural Relief Advances Act, 1938*, being chapter 42 of the Statutes of Alberta, 1938, is hereby amended as to section 12 by striking out the words "the lands in respect of which the advance is made", where the same occur in subsection (3), and by substituting therefor the words "the lands in respect of which the advance is made and in any other lands".

3. The said Act is further amended as to section 13 by striking out clause (b) of subsection (1) thereof and by substituting therefor the following:

"(b) A lien upon all crops grown or to be grown in the year in which the advance is made and in each of the next ensuing three years upon the land in respect of which the advance was made and upon any other land farmed by the recipient, having priority over all claims and demands of whatsoever kind, nature and description, save and except only as is otherwise provided by this Act to the contrary, and in any case such lien shall cease to exist in the event of foreclosure or sale by the owner of a mortgage which is or becomes a first registered encumbrance within the meaning of subsection (2) of section 17 of this Act from and after the date of such foreclosure or sale."

4. The said Act is further amended as to section 15 by striking out the words "any advance of any commodity under this Act", where the same occur in subsection (1), and by substituting therefor the words "any advance of any commodity under this Act or under *The Agricultural Relief Advances Act*, being chapter 33 of the Statutes of Alberta, 1936".

5. This Act shall come into force on the day upon which it is assented to.
