

Bill No. 58 of 1939.

A BILL TO AMEND THE LICENSING OF TRADES
AND BUSINESSES ACT, 1937.

NOTE.

This Bill amends section 4 of *The Licensing of Trades and Businesses Act, 1937*, and provides for the differentiation in the fees payable under the Act by corporations, the majority of the capital of which is owned by persons resident within the Province. (Section 2.)

The Bill confirms, ratifies and validates the Ministerial orders which have heretofore been made in pursuance of the Act and are now in force, as set out in section 3.

An Act to Amend The Licensing of Trades and Businesses Act, 1937.

(Assented to _____, 1939.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Licensing of Trades and Businesses Act, 1937, Amendment Act, 1939.*"

2. *The Licensing of Trades and Businesses Act, 1937*, being Chapter 1 of the Statutes of Alberta, 1937 (Third Session), is hereby amended as to section 4 by striking out the words "and different descriptions or classes thereof", where the same occur in paragraph (f), and by substituting therefor the words "and different descriptions or classes thereof, or in respect of businesses which are owned or operated or controlled by corporations, the majority of the capital whereof is owned by persons who are resident within the Province and businesses which are owned or operated or controlled by corporations, the majority of the capital whereof is not so owned".

3. The following orders made by the Minister of Trade and Industry in the purported exercise of the powers conferred upon him by the said Act are hereby confirmed and ratified and are declared to have the same force and effect as if the same had been enacted as a part of the said Act, namely,—

(1) An order of the Minister dated the second day of November, 1937, providing for the licensing of saw-mills, a copy of which was published in *The Alberta Gazette*, dated November 15, 1937, and being part 21 of volume 33;

(2) An order of the Minister making general regulations respecting licenses dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(3) An order of the Minister re auctioneers dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette*, dated December 13, 1938;

(4) An order of the Minister re the automotive industry dated the ninth day of December, 1938, a copy of which was

published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(5) An order of the Minister re the baking industry dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(6) An order of the Minister re the barber trade dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(7) An order of the Minister re cleaning and dyeing dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(8) An order of the Minister re flour milling, feed milling, meat packing dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(9) An order of the Minister re funeral directors dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(10) An order of the Minister re hawkers and pedlers dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(11) An order of the Minister re junk dealers dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(12) An order of the Minister re photo finishing industry dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(13) An order of the Minister re commercial printing dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(14) An order of the Minister re restaurants dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(15) An order of the Minister re retail trade dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(16) An order of the Minister re trade schools dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

(17) An order of the Minister re wholesalers dated the ninth day of December, 1938, a copy of which was published in an extra issue of *The Alberta Gazette* dated December 13, 1938;

4. This Act shall come into force on the day upon which it is assented to.
