Bill No. 62 of 1939.

A BILL TO AMEND THE LEGISLATIVE ASSEMBLY ACT.

NOTE.

This Bill amends *The Legislative Assembly Act* by reducing the total number of the members of the Legislative Assembly from sixty-three to fifty-seven; and by reducing the number of members for each of the electoral divisions of Calgary and Edmonton from six to five.

The amendment to the Schedule sets out a new distribution of the Province into electoral divisions and the boundaries of each such division.

An Act to Amend The Legislative Assembly Act.

(Assented to

, 1939.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

- 1. This Act may be cited as "The Legislative Assembly Act Amendment Act, 1939."
- 2. The Legislative Assembly Act, being chapter 3 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 3 by striking out the same and by substituting therefor the following:
- "3. Each of the electoral divisions mentioned and defined in Schedule 1 to this Act shall return one Member, except the electoral divisions at Edmonton and Calgary which shall each return five Members."
- 3. The said Act is further amended as to Schedule I thereto by striking out the same and by substituting therefor the following:

SCHEDULE I.

meridian; thence north along the east boundary of township 58, range 5, west of the 5th meridian to the north-east corner of the said township; thence west along the north boundary of township 58, ranges 5 to 7, inclusive, west of the 5th meridian, to the intersection with the meridian between ranges 7 and 8, in township 59, west of the 5th meridian; thence north along the meridian between ranges 7 and 8, west of the 5th meridian to the point of commencement.

"Electoral Division of Grouard, the boundary whereof is as follows: Commencing at the intersection of the Smoky River with the north boundary of township 82, range 22, west of the 5th meridian; thence east along the north boundary of township 82, ranges 22 to 1, inclusive, west of the 5th meridian, and ranges 26 to 21, inclusive, west of the 4th meridian to the north-east corner of township 82, range 21, west of the 4th meridian; thence south along the meridian between ranges 20 and 21, west of the 4th meridian to the north-east corner of township 76, range 21, west of the 4th meridian; thence west along the north boundary of township 76, ranges 21 to 24, inclusive, west of the 4th meridian to the north-east corner of township 76, range 25, west of the 4th meridian; thence south along the meridian between ranges 24 and 25, west of the 4th meridian to the north-east corner of township 63, range 25, west of the 4th meridian; thence west along the north boundary of township 63, ranges 25 to 27, inclusive, west of the 4th meridian, and ranges 1 to 3, inclusive, west of the 5th meridian to the intersection with the Athabaska River on the north boundary of township 63, range 3, west of the 5th meridian; thence in a generally northerly direction downstream along the Athabaska River to the inter-section with the north boundary of township 65, range 3, west of the 5th meridian; thence west along the north boundary of township 65, ranges 3 to 21, inclusive, west of the 5th meridian, to the intersection with the Little Smoky River on the north boundary of township 65, range 21, west of the 5th meridian; thence in a generally northerly direction downstream along the Little Smoky River to the intersection with the north boundary of township 73, range 19, west of the 5th meridian; thence west along the north boundary of township 73, ranges 20 to 24, inclusive, west of the 5th meridian, to the north-east corner of township 73, range 25, west of the 5th meridian; thence north along the meridian between ranges 24 and 25, west of the 5th meridian to the intersection with the Smoky River on the east boundary of township 76, range 25, west of the 5th mer-idian; thence in a generally northerly direction downstream along the Smoky River to the point of commencement.

4. This Act shall come into force on the day upon which it is assented to.
