A BILL TO AMEND THE ALBERTA GOVERNMENT PURCHASING AGENCY ACT.

NOTE.

This Bill amends The Alberta Government Purchasing Agency Act.

The amendments to section 2 specifically mention the King's Printer and the Department of Railways and Telephones in the definition of the term "Department" and delete printing from the definition of the word "Supplies".

Subsection (1) of section 6 designates the officials who shall be on The Advisory Purchasing Committee. As the Director of Purchases and the Chairman of the Marketing Board are now one and the same person, it is advisable to amend this section to make it clear that a committee of two is competent to do any or all of the things which the Advisory Purchasing Committee is empowered to do under this Act.

An Act to Amend The Alberta Government Purchasing Agency Act.

(Assented to , 1941.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "The Alberta Government Purchasing Agency Act Amendment Act, 1941."

2. The Alberta Government Purchasing Agency Act, being chapter 7 of the Statutes of Alberta, 1939, is hereby amended as to section 2,—

- (a) by striking out paragraph (b) thereof and by substituting therefor the following:
 - "(b) 'Department' means every department of the Government of the Province and every branch thereof and every Board, the expenses of which are paid out of the General Revenue Fund, and without limiting the generality of the foregoing includes the Workmen's Compensation Board, the Alberta Liquor Control Board, the King's Printer, and the Department of Railways and Telephones;"
- (b) by striking out the words "all printing" where the same occur in paragraph (e) thereof.

3. The said Act is further amended as to section 6 by striking out subsection (1) thereof and by substituting therefor the following:

"6.—(1) There is hereby constituted for each Department an advisory committee which shall include the chairman of the Marketing Board established pursuant to *The Alberta Marketing Act*, one other person representing the Department who shall be appointed by the head of that Department, and such other person, if any, as the Lieutenant Governor in Council may designate, but shall not in any case consist of more than three members, the committee to be known as 'The Advisory Purchasing Committee' for that Department, and the duties of each such committee shall be to determine as to the necessity for the acquisition of any supplies of any kind by the Department for which it is constituted, and as to the amount of any supplies

which ought to be acquired from time to time and as to the quality, nature, kind and description of any such supplies and as to the persons from whom such supplies shall be acquired."

4. This Act shall come into force on the day upon which it is assented to.
