A BILL TO VALIDATE AND RATIFY A CERTAIN
AGREEMENT BETWEEN THE LLOYDMINSTER
MUNICIPAL HOSPITAL BOARD AND THE
LLOYDMINSTER AND DISTRICT
HOSPITAL BOARD

NOTE.

This Bill validates an agreement between the Lloydminster Hospital Boards entered into in 1919. The Alberta Board and Saskatchewan Board at that time agreed to jointly operate a hospital for the residents of the Lloydminster district, and the hospital has been operating pursuant to this agreement ever since. The agreement was ratified so far as the Saskatchewan Board was concerned by special Act of the Saskatchewan Legislature. Some of the clauses in the agreement, however, may be beyond the competence of the Alberta Board, and this Bill is for the purpose of confirming the agreement and all proceedings taken pursuant to it.

An Act to Validate and Ratify a Certain Agreement Between the Lloydminster Municipal Hospital Board and the Lloydminster and District Hospital Board.

(Assented to _____, 1941.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. The agreement dated the tenth day of December, A.D., 1919, made between the Lloydminster Municipal Hospital Board incorporated under *The Municipal Hospitals Act* in the Province of Alberta, and the Lloydminster and District Hospital Board incorporated by special Act of the Legislature in the Province of Saskatchewan and signed by G. M. Cook, Chairman, and T. B. MacKay, Secretary, on behalf of the Lloydminster Municipal Hospital Board, and by H. Huxley, Chairman, and S. M. Daly, Secretary, on behalf of the Lloydminster and District Hospital Board, as altered and amended from time to time pursuant to the terms of the said agreement, is hereby validated, approved, ratified, confirmed and declared to be in full force and effect.

2. This Act shall come into force on the day upon which it is assented to, and upon so coming into force shall be deemed to have been in force at all times on and after the tenth day of December, A.D., 1919.
