

Bill No. 33 of 1942.

A BILL TO AMEND THE TEACHERS' RETIREMENT
FUND ACT.

NOTE.

This Bill amends the definition of "teacher" so as to extend the benefits of the Act to teachers with Alberta certificates who are teaching in the Lloydminster schools, which are governed by Saskatchewan legislation. The Act, if passed, will require approval by the Province of Saskatchewan which may be given by Order in Council under *The Lloydminster Municipal Amalgamation Act*. The above amendment makes necessary the amendments made by sections 3 and 4 of the Bill. The amendments to section 5 authorize the Board to make refunds in case of the death of a teacher, to his immediate relatives, and change the date prescribed for the annual return of the Board to the Department of Education.

An Act to amend The Teachers' Retirement Fund Act.

(Assented to _____, 1942.)

HIS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

1. This Act may be cited as "*The Teachers' Retirement Fund Act Amendment Act, 1942.*"

2. *The Teachers' Retirement Fund Act*, being chapter 21 of the Statutes of Alberta, 1939, is hereby amended as to section 2 by striking out paragraph (c) and substituting therefor the following:

"(c) 'Teacher' means any person holding a valid certificate of qualification issued under the regulations of the Minister of Education of the Province of Alberta, who is employed,—

"(i) by the board of trustees of a school district or a school division formed and constituted under *The School Act, 1931*, in the capacity of a teacher in a school;

"(ii) by the Lloydminster Public School District or the Lloydminster High School District in the capacity of a teacher in a school;

"(iii) as a superintendent, supervisor, principal or other such official of a school district or a school division formed and constituted under *The School Act, 1931*;

"(iv) by the Alberta Teachers' Association."

3. The said Act is further amended as to section 5,—

(a) by inserting after the word "Alberta", where it occurs in the third line of paragraph (a) of subsection (1), the following words: "and of the Lloydminster Public School District and the Lloydminster High School District";

(b) by inserting after the words, "*The School Act, 1931*", where they occur in the seventh line of paragraph (b) of subsection (1), the following words: "and from the grants payable to the Lloydminster Public School District and the Lloydminster High School District."

4. The said Act is further amended as to section 6a,—
- (a) by inserting after the words, "school division", where they occur in the third and fourth lines of subsection (1), the following: "and of the Lloydminster Public School District and the Lloydminster High School District."
 - (b) by adding after the words, "*The School Act, 1931*", where they occur in the seventh line of subsection (2), the following words: "and pursuant to *The Border Areas Act, 1924*, or *The Lloydminster Municipal Amalgamation Act, 1930*."
5. The said Act is further amended as to section 8,—
- (a) by striking out the words "to refund and pay to, or to the estate of any teacher who has contributed to the said fund", where the same occur in subsection (1) thereof, and by substituting therefor the following words: "to refund and pay to any teacher who has contributed to the said fund, or to his estate, widow, or widower, or to his next-of-kin who are members of his immediate family";
 - (b) by striking out subsection (3) and substituting therefor the following:

"(3) On or before the thirty-first day of December of each year the Board shall furnish to the Department of Education an audited statement showing the standing of the Fund as at the thirty-first day of August preceding and containing such other information as the Lieutenant Governor in Council may from time to time require."
6. The said Act is further amended as to section 8a by adding at the end thereof the following words: "which shall be remitted to the Board and credited to the reserve account mentioned in subsection (2) of section 5."
7. This Act shall come into force on the day upon which it is assented to and upon so coming into force shall be deemed as to sections 2 and 3 to have been in force since the first day of September, 1939, and as to section 4 from the first day of July, 1941.
