A BILL TO AMEND THE DENTAL ASSOCIATION  
ACT.

NOTE.

This Bill amends *The Dental Association Act*.

Section 2 of the Bill increases the annual fees payable by members of the Association from ten dollars to thirty-five dollars.

Section 3 introduces a new section 25a which defines what is included in the term the practice of dentistry.

Section 4 amends section 29 of the Act (which deals with penalties) by applying it to the four preceding sections instead of three.

Section 5 adds a new section 29a which prohibits a person, not registered, from practising dentistry or holding himself out as being qualified to practise or holding out or advertising any other person who is not registered as being so qualified.

Section 6 provides that the provisions of the Bill shall not affect the provisions of *The Public Health Act*, section 24a, and regulations relating to the relationship between dentists and dental mechanics.

# BILL

No. 72 of 1942.

An Act to amend The Dental Association Act.

(Assented to \_\_\_\_\_, 1942.)

**H**IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Alberta, enacts as follows:

**1.** This Act may be cited as "*The Dental Association Act Amendment Act, 1942.*"

**2.** *The Dental Association Act*, being chapter 204 of the Revised Statutes of Alberta, 1922, is hereby amended as to section 13 by striking out the words "ten dollars", where the same appear in the fifth line of subsection (1), and by substituting therefor the words "thirty-five dollars".

**3.** The said Act is further amended by inserting immediately after section 25, the following new section:

"**25a.** Any person shall be deemed to be practising the profession of dentistry within the meaning of this Act, who, for a fee, salary, reward, or commission, paid or to be paid, by any employer to him, or for fee, money, or compensation, paid, or to be paid, either to himself, or any employer or any other person,—

"(a) examines, diagnoses, or advises, on any condition of the tooth or teeth, in the jaw or jaws, of any person; or

"(b) directly in the oral cavity of any person, takes, makes, performs or administers any impression, operation or treatment or any part of any impression, operation or treatment of any kind, of or upon the tooth or teeth, jaw or jaws, or of, for or upon any disease or lesion of the tooth or teeth, jaw or jaws, or the malposition thereof, in the mouth of any person; or

"(c) fits any artificial denture, tooth or teeth, in, to or upon, the jaw or jaws, of any person; or

"(d) advertises or holds himself out as being qualified or entitled to do all or any of the above things."

**4.** The Act is further amended as to section 29 by striking out the word "three", where it occurs in the second line thereof, and by substituting therefor the word "four".

**5.** The said Act is further amended by inserting immediately after section 29 the following new section:

**“29a.** No person not registered under this Act shall, within the Province, directly or indirectly offer to practice, or hold himself out as being qualified or entitled to practice, the profession of dentistry either within the Province or elsewhere, and no person shall, within the Province, directly or indirectly hold out or represent any other person not registered under this Act as practising or as qualified or entitled or willing to practise the profession of dentistry in the Province or elsewhere, or circulate or make public anything designed or tending to induce the public to engage or employ as a dentist any person not registered under this Act.”

**6.** None of the provisions of this Act shall be construed as affecting in any way the provisions of section 24a of *The Public Health Act* or of the regulations made pursuant to section 7 of that Act and where there is any conflict between any of the provisions of this Act and section 24a of *The Public Health Act* or the said regulations, the provisions of *The Public Health Act* and the regulations thereunder shall prevail.

**7.** This Act shall come into force on the day upon which it is assented to.
